



MADHEPURA MUNICIPAL CONCILE (LICENSE FOR SALE OF ANIMAL FLESH, FISH OR POULTRY) REGULATION, 2014

(U/S 345 of Bihar Municipal Act, 2007)

In exercise of power conferred under Section 129(c) (read with Section 345 and Section 421) of the Bihar Municipal Act, 2007, the Madhepura Municipal council has formulated the following regulations for proper control of trade of a butcher, fish monger, poulturer of importer of animal flesh. These regulations have been opted by the Ward councilors at their meeting dated 31-08-2013 which will be made effective from the date of its publication in the Official Gazette after due approval of the Bihar State Government.

1. Conditions for Trading.

No person shall, without or otherwise in conformity with a license secured from Municipal Officer or Other Officer authorized by him in this regard, carry on the trade of a butcher, fish monger, poulturer or importer of animal flesh, intended for human Consumption or for use of any place for sale of animal flesh, fish or poultry intended for human consumption.

2. Application for Trading.

As soon as any person resolves to carry on the trade of a butcher, fish monger, poulturer or importer of animal flesh, he/she shall approach the Chief Municipal Officer/ or an Executive Officer authorized by Chief Municipal Officer and submit an application, in prescribed form, as mentioned in Schedule of this Regulation. If a person is already in trade of a butcher, fish monger, poulturer or importer of animal flesh, he or she have to submit an application in prescribed format for the trade license within one month of the publishing of this Regulation in local newspaper, failin which he/she shall be liable to pay a fine of Rs. 1,000.00 which seizure on each instance.

3. Processing of the application.

The application received from the applicant will be handed over to the License Inspector by the Chief Municipal Officer, Madhepura Municipal Council/or an official authorized by him who after spot enquiry shall submit his report to the corporation.

4. Decision on the application.

The Chief Executive Office, Madhepura, Municipal Council or his authorized representative will consider the report submitted by the License Inspector and take final decision on the application.

Provided in case of rejection, the cause of rejection will be recorded and communicated to the applicant.

5. Issue of license.

The Chief Municipal Officer/Executive Officer or his authorized representative shall issue the license in prescribed form as mentioned in Schedule II of this regulation. The License shall bear the seal of the corporation and signature of the Chief Municipal Officer or officer authorized by him.

6. License Fee.

Before issue of license, the applicant shall have to deposit an Annual License Fee of Rs. 500.00 for which a money receipt shall be granted by the Patna Municipal corporation. No fee will be charged from the applicant who belongs to Below Poverty Line (BPL) Category. However, he/she will have to pay a processing fee of Rs. 20.00 (Twenty Rupees) only.

7. Rejection of application for license.

In case the application for license is rejected, its information along with cause of rejection shall be communicated to the applicant within a month of receipt of application by the Chief Municipal Officer or his authorized official.

8. Renewal of License.

Renewal of license may be made on receipt of application in Schedule I along with Annual License Fee of Rs. 500.00. A sum of Rs. 200.00 per month as late fee up to three months from expiry of last date of the earlier License will be charged for late submission, provided that in any case no further extension of date shall be granted. After three months his/her business premises shall be sealed by the Council and recovery proceeding for the dues for the period of business along with the prescribed fine shall be initiated in accordance with the Madhepura Municipal Council Tax and Non-Tax dues Recovery Regulations, 2013.

Terms and Conditions of License.

- 9.1 No person shall sell, or expose for sale, any flesh obtained from an animal unless the skinned carcass of the animal is stamped in such manner as the Chief Municipal Officer or his authorized Official may, by general order made in this behalf, require as token of the fact that the animal has been slaughtered in a municipal or license slaughter house.
- 9.2 No license shall be required for any place used for sale or storage for sale, of preserved animal flesh or fish contained in air tight or hermetically sealed receptacles.
- 9.3 The Chief Municipal Officer/Executive Officer or his authorized official may require the licensee to take all or any of such measures as may deem fit to guard against danger to life or health or property or for the abatement of nuisance of any kind.
- 9.4 A licensee must renew his license on month before last date of expiry.

- 9.5 All premises licensed for use in trade mentioned under this regulation shall be kept clean and hygienic so as not to be detrimental to public health.
- 9.6 All refuse from the process of carrying on any mentioned trade, or all and any other material, spread, injurious effluvia shall be removed, if so required, from the premises daily, and deposited in such place as may be approved by the Patna Municipal Corporation.

10. suspension or Revocation of License.

The Chief Municipal Officer shall suspend or revoke the license of traders in case of committing breach of any condition such as :-

- (i) Unhygienic condition of the trading premises and its surroundings.
- (ii) Any dangerous act which is hazardous to others.
- (iii) Slaughtering of animal under cruelty ground wherein slaughtering of animal in front of another.
- (iv) Any act of environmental pollution.
- (v) If the authorized official has issued License in contravention to the provision stipulated U/s 338 of Bihar Municipal Act 2007.
- (vi) Any violation of the rules and regulations as laid down during which the Premises shall be confiscated.
- (vii) The Licensing authority may suspend/cancel or revoke license if in his view the non residential activity or trade is causing nuisance, hazard to general Health an safety or traffic hazard for public.

11. Display of License.

The licensee shall have to display the license at such a prominent place in his trading premises, so that every visitor can observe it easily. Failure to do so may lead to cancellation of license.

12. Inspection of Trading Places.

It shall be open to Chief Executive Officer (MC)/Executive Officer to depute any officer to inspect such trading places at any time by general or special order. Further the Sanitary Inspector or any other personnel authorized by Executive Officer shall make visit to such trading places periodically and ensure whether the licensee is trading the same trade for which license has been issued or he has changed the trade without proper permission of Madhepura Municipal Council or whether he is meeting all conditions specified in the License. In case of any irregularity or non-compliance, the license shall be suspended after providing opportunity ot respond to show cause notice.

13. Removal of difficulties.

If any difficulty arises in giving effect to the provisions of this Regulation, the Madhepura Municipal Council may, as occasion may require, act as necessary for removing the difficulties.

This license is valid for one year only from date of its issue subject to annual renewal after depositing requisite fee.

1. Terms and conditions of license :

1. The license shall have to abide by the rules and regulations and orders issued by the Commissioner, Madhepura Municipal Council from time to time.
2. In case of violation of any rules and regulations, the license shall deem to be cancelled and during the suspension the shop shall be confiscated.
3. No person shall sell, or expose for sale, any flesh obtained from an animal unless the skinned carcass of the animal is stamped in such manner as the Chief Municipal Officer or his authorized official may, by general order made in this behalf, require as token of the fact that the animal has been slaughtered in a municipal or licensed slaughter house.
4. No license shall be required for any place used for sale or storage for sale, of preserved animal flesh or fish contained in air tight or hermetically sealed receptacles.
5. The Chief Municipal Officer or his authorized official may require the licensee to take all or any of such measures as may deem fit to guard against danger to life or health or property or for the abatement of nuisance of any kind.
 - a. A licensee must renew his license before last date of expiry.
 - b. All premises licensed for use in trade mentioned under this regulation shall be kept clean and hygienic so as not to be detrimental to public health.

c. All refuse from the process of carrying on any mentioned trade, or all and any other material, spread, injurious effluvia shall be removed. If so required, from the premises daily, and deposited in such place as may be approved by the Patna Municipal Corporation.

6. Suspension or Revocation of License.

The Chief Municipal Officer shall suspend or revoke the license of traders in case of committing breach of any condition such as :-

- a. Unhygienic condition of the trading premises and its surroundings.
- b. Any dangerous act which is hazardous to others.
- c. Slaughtering of animal under cruelty ground wherein slaughtering of animal in front of another.
