SYNOPSIS

The present Writ Petition is for issuance of an appropriate Writ in the nature of certiorari for quashing the notification as contained in Memo No. 1866/13 dated 19.07.2013 (Annexure - 1) issued under the signature of the Registrar of the Respondent University as per the order of the Vice chancellor of the Respondent University by which the notification of the Petitioner as Additional Registrar has been treated to be cancelled and withdrawn and further the Petitioner who was having the charge of Examination Controller of the Respondent University has been placed under wait for further posting deputed Petitioner has been sent back to the original post of his

college from the post of Examination Controller on which the Petitioner was on deputation and further the Respondent No. 7 who is OSD in Examination Department has been deputed as Controller of Examination of the Respondent University with immediate effect till further order and for issuance of an appropriate Writ holding and declaring that the aforesaid order as contained in Annexure - 1 is wholly arbitrary, unreasonable, malafide and without Jurisdiction & even in violation of the principles of natural Justice as well as in misuse of the specific powers for discharging of day to day function of the Vice Chancellor given by the Hon'ble Supreme Court vide their order dated 16.04.2013 & 23.04.2013 passed in Special Leave to Appeal (C) no. 12409 & 8066 of 2013.

Hence this Writ Petition.

**Most Respectfully Sheweth:-**

1. That this Writ Petition is being filed on behalf of the Petitioner for the following reliefs:

- a. For issuance of an appropriate Writ in the nature of certiorari for quashing the notification as contained in Memo No. 1866/13 dated 19.07.2013 (Annexure - 1)

issued under the signature of the Registrar of the Respondent University as per the order of the Vice chancellor of the Respondent University by which the notification of the Petitioner as Additional Registrar has been treated to be cancelled and withdrawn and further the Petitioner who was having the charge of Examination Controller of the Respondent University has been placed under wait for further posting deputed Petitioner has been sent back to the original post of his college from the post of Examination Controller on which the Petitioner was on deputation and further the Respondent No. 7 who is OSD in Examination Department has been deputed as Controller of Examination of the Respondent University with immediate effect till further order.

A Photo Copy of the Office order dated 19.07.2013 is annexed herewith and marked as Annexure - 1 to this Writ Petition.

- b. For issuance of an appropriate Writ holding and declaring that the aforesaid order as contained in Annexure - 1 is wholly arbitrary, unreasonable,

malafide and without Jurisdiction & even in violation of the principles of natural Justice as well as in misuse of the specific powers for discharging of day to day function of the Vice Chancellor given by the Hon'ble Supreme Court vide their order dated 16.04.2013 & 23.04.2013 passed in Special Leave to Appeal (C) no. 12409 & 8066 of 2013.

- c. For issuance of any other relief/s for which the Petitioner is entitled in the eye of law and in the facts and circumstances of the case.
2. That the Petitioner is a citizen of India and as such invokes extraordinary Jurisdiction of this Hon'ble Court for redressal of his grievances.
  3. That the instant Writ Petition assailing the impugned order as contained in Annexure -1 is being preferred by the Petitioner on the following GROUNDS:-
    - i. For that the impugned order has been passed by an order of an authority who has absolutely no Jurisdiction to pass the impugned order as his appointment is for a temporary period as per the direction of the Hon'ble Supreme Court, his services



was only meant for day to day function of the University.

- ii. For that the impugned order is wholly arbitrary, malafide and in teeth of the role assigned to the Respondent Vice Chancellor appointed for a temporary basis by the Hon'ble Supreme Court with a power to discharge day to day function,
- iii. For that the Petitioner duly holding and assigned the aforesaid post on deputation can not be removed by a Vice Chancellor having the powers given only with regard to day to day affairs of the University.
- iv. For that the temporary Vice Chancellor in the garb of the powers of discharging day to day function can not pass the impugned order to appoint/depute his favourites on the said post.
- v. For that the impugned decision of the Respondent University is wholly malicious and the same is only to bring his own person on the post of the Petitioner taking the advantage/shelter of the post of Vice Chancellor meant for a temporary period and that too for day to day work of the University.
- vi. For that the reasoning given for passing the impugned order is wholly vague and absolutely vague reasoning has been indicated in the impugned order.

- vii. For that the impugned order passed by the Vice Chancellor is for fulfilling personal vendetta and for the reasons quite obvious and well known to him.
  - viii. For that the Respondent Vice Chancellor can not appoint/depute the Persons of his choice on extraneous consideration during his tenure when he has only to discharge day to day function of the University.
  - ix. For that the impugned order is in teeth of the principles of natural Justice as no such show cause has been asked from the Petitioner and nor reasonable opportunity has been given to the Petitioner before passing the impugned order.
  - x. For that the impugned order is even otherwise bad in law and is fit to be quashed.
4. That pursuant to the decision taken in the meeting of the Syndicate dated 21.01.2013, the Petitioner being posted as Officer on Special Duty (OSD) in the Examination Department of the Respondent University was given the charge of Additional Charge of the Respondent University vide office notification as contained in Memo No. 24/13 dated 22.01.2013 issued under the signature of the Registrar of the Respondent University as per the order of the Vice Chancellor. The aforesaid

notification/office order was communicated to all the authorities. The Petitioner subsequently gave his joining on the said post of Additional Registrar on 22.01.2013 itself which was allowed by the Vice Chancellor of the University.

A Photo Copy of the notification dated 22.01.2013 is annexed herewith and marked as Annexure - 2 to this Writ Petition.

5. That the Petitioner subsequent to the aforesaid notifications took the charge of Additional Registrar and began to discharge his obligations on the said post to the best of his sincerity and ability and that too without any complaint from any sort and even without disturbance from/at any sources.
6. That the Respondent University vide its notification bearing Memo No. 408/13 dated 11.02.2013 issued the appointment letter of the Petitioner to the effect that the Petitioner, Associate professor in P.G. Department of Chemistry is being appointed as Examination Controller-cum Additional Registrar of the Respondent University from the date of his joining till further orders. The Petitioner was directed to give his joining with immediate effect.

A Photo Copy of the notification dated 11.02.2013 is annexed herewith and marked as Annexure - 3 to this Writ Petition.

7. That all of a sudden, the impugned notification as contained in Annexure - 1 dated 19.07.2013 has been issued by the Respondent University by which notification of the Petitioner as Additional Registrar has been treated to be cancelled and further the Petitioner who was having the charge of Examination Controller of the Respondent University has been placed under wait for further posting deputed Petitioner has been sent back to the original post of his college from the post of Examination Controller on which the Petitioner was on deputation and further the Respondent No. 7 who is OSD in Examination Department has been deputed as Controller of Examination of the Respondent University with immediate effect till further order.
8. That it would be pertinent to state here that the Petitioner has neither been issued any show cause or given any opportunity of hearing at any stage before passing the impugned order.

9. That it would be important to state certain facts about the existence of Respondent No. 2 as the Vice Chancellor of the Respondent University. At this stage, it would be pertinent to bring to the kind notice of this Hon'ble Court that the appointment of several Vice Chancellors of the Universities of the State of Bihar including the appointment of the Vice Chancellor of the Respondent University was challenged before the Hon'ble Patna High Court by C.W.J.C. No. 15123 of 2011 mainly on the ground that without consultation of the state Govt. as mandatorily required under the law, the said appointments were made. The Hon'ble Division Bench of Patna High Court vide its order dated 07.12.2012 set aside the appointment of the Vice Chancellors by giving certain directions to the Hon'ble Chancellor. The Hon'ble Chancellor in compliance of the order passed by the Hon'ble Division Bench issued notification dated 09.02.2013 with regard to the Vice Chancellor of the Universities including the name of the Vice Chancellor of ~~Tilka Manjhi~~ <sup>Bhupendra Narayan</sup> ~~Mandal~~ Bhagalpur University.

10. That the order passed by the Hon'ble Division Bench was challenged before the Hon'ble Supreme Court by the Writ Petitioner who has assailed the appointment of the Vice Chancellor in this Hon'ble Court as well as by the State of Bihar. The aforesaid case was numbered as Special Leave to Appeal

(Civil) No. 12409 of 2013 and the Hon'ble Supreme Court vide its order dated 18.03.2013 by its detailed order stayed the operation of the notifications dated 09.02.2013 issued by the Governor cum Chancellor appointing Vice Chancellors and Pro Vice Chancellors. The Hon'ble Supreme Court in the same Proceeding vide its order dated 16.04.2013 directed the Chancellor that wherever he considers necessary, appoint senior most from amongst the Deans or members of the Faculty for discharging of day to day function and subsequently at the oral request of the Hon'ble Chancellor, the Hon'ble Supreme Court vide its order dated 23.04.2013 had given observation with regard to appointment under the powers conferred u/s 13 of the Bihar State University Act.

11. That pursuant to the aforesaid direction of the Hon'ble Supreme Court, the Hon'ble Chancellor vide its notification giving reference to the aforesaid date and order of the Hon'ble Supreme Court dated 18.03.2013, 16.04.2013 & 23.04.2013 appointed the Respondent No. 2 as the Vice Chancellor of the University as a temporary arrangement. *for 27.4.13*
12. That from the perusal of the aforesaid order of the Hon'ble Supreme Court as well as the provisions u/s 13 of the Bihar State University Act, it would be apparent that the appointment

*Day to day work*

of Respondent No. 2 was for day to day affairs of the University. Day to day affairs of the University does not include removal, appointment, confirmation of service, transfer, absorption, constitution of Regular Governing Body etc. rather day to day means discharge of routine work only. In charge of Day to day affairs, the Respondent No. 2 could not have dared to touch any acts done by the Regular Vice Chancellor of the University and he should have restrained from doing so but the Respondent No. 2 for the reasons best known have passed the impugned order.

13. That the Respondent No. 2 began to function as the Vice Chancellor of the University meant for day to day to day affairs of the University from 27.04.2013 and became over enthusiastic in way of bringing his own persons on several posts by removing the Persons who have been appointed in accordance with law by the Regular Vice Chancellor.

14. That the Respondent No. 2 has exceeded its Jurisdiction in passing the impugned order and that too without any reason. No specific reason has been assigned in the impugned order for passing the impugned order.

15. That the impugned order has been passed by an order of an authority who has absolutely no Jurisdiction to pass the impugned order as his appointment is for a temporary period as per the direction of the Hon'ble Supreme Court and his services

was only meant for day to day function of the University and not for the purposes for which the impugned order has been passed.

16. That the impugned order is wholly arbitrary, malafide and in teeth of the role assigned to the Respondent Vice Chancellor appointed for a temporary basis by the Hon'ble Supreme Court with a power to discharge day to day function. The Petitioner duly having the charge of the said post, can not be removed by a Vice Chancellor having the powers given only with regard to day to day affairs of the University.

17. That it would be essential to state here that several letters/orders/notifications issued by the Respondent No. 2 during his temporary appointment which would demonstrate and establish the fact that he is acting in such a manner as if he is Regular Vice Chancellor and he is even overlooking the order passed by the Hon'ble Supreme Court as well as the provisions as contained in section 13 of the Bihar State University Act by which he has only been conferred the power of day to day affairs. It is not expected from a Temporary Vice Chancellor to annul the acts done by the Regular Vice Chancellor. The entire exercise is being done by the Respondent No. 2 for his personal benefits and as such he under the temporary powers is doing every thing to bring his own persons by passing impugned order for the obvious reason including extraneous consideration. He is even not acting in accordance with law. The Petitioner brings on record certain documents for kind perusal and appreciation of this Hon'ble Court. The aforesaid documents would indicate the high handedness of the Respondent No. 2 in discharging his duty of day to day affairs and as such the Respondent no. 2 should be



restrained by this Hon'ble Court in interfering with the decisions taken by the Regular Vice Chancellor.

18. That it would be pertinent to state here that during his term as temporary Vice Chancellor meant for discharge of day to day affairs, the Respondent No. 2 should have taken care that the decision taken by the Regular Vice chancellor should not have been touched and the settled things should not have been unsettled.
19. That the impugned decision of the Respondent University is wholly malicious and the same is only to bring his own persons on the said post taking the advantage/shelter of the post of Vice Chancellor meant for a temporary period and that too for day to day work of the University.
20. That the reasoning given for passing the impugned order is wholly vague and absolutely vague reasoning has been indicated in the impugned order.
21. That the impugned order is in teeth of the principles of natural Justice as no such show cause has been asked from the Petitioner and nor reasonable opportunity has been given to the Petitioner before passing the impugned order.

22. That the acts of the Respondent University amount to Promissory estoppels and is in teeth of the principles of natural justice.
23. That in view of the aforesaid facts and grounds, the Petitioner prays that this Hon'ble Court may allow the present Writ Petition in favour of the Petitioner and quash the impugned order as contained in Annexure - 1 of the Writ Petition so far as the Petitioner is concerned.
24. That the action of the Respondent University is wholly arbitrary, malafide and contrary to the established principles of law.
25. That the Petitioner craves leave of this Hon'ble Court to produce all the relevant documents in support of the submissions and statements as made above by way of Supplementary Affidavit at the time of hearing of this case if required by this Hon'ble Court.
26. That in the circumstances stated above, the Petitioner has no other alternative and efficacious remedy than to move this Hon'ble Court for redressal of their grievances.
27. That the Petitioner has not moved this Hon'ble Court any time earlier for the reliefs as prayed in Para 1 of the instant writ petition.

It is therefore, prayed that your lordships may be pleased to issue Rule NISI calling upon the Respondents to show cause as

to why the reliefs as prayed in Para 1 of this writ petition be not allowed and after hearing the parties, make the rule absolute.

And/or

During the pendency of the Writ Petition, the operation of the order dated 19.07.2013 as contained in Annexure -1 may kindly be stayed.

And/Or

During the pendency of the Writ Petition, the Respondent be directed to do the work of only day to day affairs.

And/Or

Pass such other order/s as your lordships may deem fit and proper in the facts and circumstances of the case.

And for this the Petitioner shall ever pray.







**SUPPLEMENTARY AFFIDAVIT ON BEHALF OF THE PETITIONER**

I, Arun Kumar Yadav, aged about 53 years, Son of Late Shri P.P. Yadav, Resident of Village + P.O. - Bhirkhi North, P.S. - Madhepura, District - Madhepura, do hereby solemnly affirm and state as follows:-

1. That I am the Petitioner in the instant case and as such am well acquainted with the facts and circumstances of the case as well the averments as stated in this Supplementary Affidavit.
2. That this Supplementary affidavit is being filed on behalf of the Petitioner bringing on record certain facts as well as documents which are essential for proper adjudication of the matter.
3. That at the outset, it would be pertinent to state here that since the Examination Controller was holding the posts for

the last three years and as such after completion of term, the University took a decision to appoint the Examination Controller and in that way, the Petitioner was appointed by order dated 11.02.2013 as contained in Annexure - 3 of the Writ Petition by the Regular Vice Chancellor of the University who was appointed by the learned Chancellor however the said appointment has been subsequently set aside by the Hon'ble Supreme Court. It is thus apparent that the Petitioner has been appointed in accordance with law by the order of Regular Vice Chancellor by a conscious decision of the University. The present In-Charge Vice Chancellor has come into existence by virtue of the order dated 26.04.2013 issued by the Hon'ble Chancellor, Universities of Bihar and the Respondent University has issued the notification dated 27.04.2013 in this regard.

A Photo Copy of the order dated 27.04.2013 is being annexed herewith and marked as Annexure - 5 to this Supplementary Affidavit forming part of the Writ Petition.

4. That it would be pertinent to bring to the kind notice of this Hon'ble Court that this Hon'ble Court in other similarly paced matters on the same questions of law having the similar issue vide its different orders had restrained the In-Charge Vice Chancellor from taking any policy decision and rather have directed them to do day to day affairs of the University but the Respondent University ignoring the said orders of the

Hon'ble Court is taking policy decision causing huge financial loss which would be apparent from the facts as stated below.

5. That the Petitioner would like to bring on record the notification dated 14.07.2010 issued by the Respondent University which would suggest the list of teachers (University Professors) under the purview of C.W.J.C. No. 5859/96 & direction of the Hon'ble Chancellor under the 16 years Time Bound Promotion Scheme. The said list would disclose that the present In-Charge Vice Chancellor namely Dr. R. N. Mishra finds place at serial no. 24 in the said list and the last column would suggest that he has been demoted.

A Photo Copy of the notification dated 14.07.2010 is being annexed herewith and marked as Annexure - 6 to this Supplementary Affidavit forming part of the Writ Petition.

6. That very surprisingly, the Registrar of the University under the orders of the Vice Chancellor issued a notification dated 06.08.2013 and have kept altogether 15 Teachers beyond the purview of C.W.J.C. No. 5859 of 2013. It would appear from the said notification that a committee was constituted by the order of the Vice Chancellor dated 30.07.2013 and on the basis of the recommendation of the said committee made under corrective measure and on the basis of the approval of the Vice Chancellor, those teachers who found place in the notification dated 14.07.2010 and were demoted, they by the

notification dated 06.08.2013 has been kept beyond the purview of C.W.J.C. No. 5859 of 2013. As per the information gathered from the sources, even the financial benefits have been released in favour of them.

A Photo Copy of the notification dated 06.08.2013 is being annexed herewith and marked as Annexure - 7 to this Supplementary Affidavit forming part of the Writ Petition.

7. That the Petitioner would like to bring on record certain notifications being issued under the order of the Vice Chancellor of the University to show and suggest that the posts are being created e.g. Registrar (Convocation) and his favourites are being given the duty to discharge the responsibility. The aforesaid act of the Vice Chancellor smells something else. The Respondent Vice Chancellor is not hesitating in doing the settled things unsettled in order to bring his person on the said chair for the reasons best known to him. The Person holding the post of Inspector of College is being sent to his original post and new person is given the said responsibility. The Petitioner would also like to bring on record the proceeding of the syndicate dated 29.08.2013 in order to show the sad affairs of the University.







01. कर्मचारियों द्वारा दिनांक-22.08.2013 से जारी हड़ताल पर विचार ।

विश्वविद्यालय स्थापना-काल से अद्यतन स्टाफिंग पैटर्न एवं सविदा पर नियुक्त एवं कार्यरत कर्मचारियों को अभिषद एवं अधिषद के निर्णयानुसार मानदेय का भुगतान किया जा रहा था। वर्तमान कुलपति डॉ० आर० एन० मेश्र के कार्यकाल में भी मई-जून 2013 हेतु मानदेय का भुगतान किया गया है लेकिन अकारण ही जुलाई, 2013 का मानदेय रोक दिया गया है जिसके कारण दिनांक-22.08.2013 से कर्मचारीगण अनिश्चितकाली हड़ताल पर हैं। आज तक कुलपति महोदय मुख्यालय नहीं आये हैं।

विमर्शोपरांत सर्वसम्मति से निर्णय लिया जाता है कि पूर्व की भाँति जुलाई-अगस्त, 2013 का मानदेय सभी कर्मचारियों को दिया जाय तथा कर्मचारियों से वार्ता कर हड़ताल समाप्त करवाई जाय।

02. हड़ताल के कारण उत्पन्न स्थिति पर विचार।

अभिषद सदस्यों ने कुलपति महोदय की उदासीनता के कारण उत्पन्न हड़ताल पर गहरा क्षोभ व्यक्त किया तथा हड़ताल के कारण उत्पन्न स्थिति पर विचार-विमर्श किया। हड़ताल के कारण स्नातक तृतीय खंड परीक्षा, 2013 का परीक्षाफल प्रकाशित नहीं हो सका जिसके कारण स्नातकोत्तर सत्र 2013-15 के प्रारम्भ करने में विलम्ब होगा। स्नातक द्वितीय खंड परीक्षा, 2013 जो दिनांक-27.08.2013 से निर्धारित थी, अनिश्चितकाल के लिये स्थगित कर दी गई है। अन्य परीक्षाएँ भी समय पर नहीं हो सकी हैं। उत्तीर्ण छात्र-छात्राओं जो नौकरी पाने वाले हैं का प्रमाण-पत्र नहीं मिल सका जिसके कारण उन्हें नौकरी से वंचित होना पड़ रहा है। इस प्रकार विश्वविद्यालय मुख्यालय में कुलपति महोदय के नहीं आने के कारण छात्र-छात्राओं को असुविधा हो रही है।

03. शिक्षकों एवं शिक्षकेत्तर कर्मचारियों को वेतन एवं बकाया वेतन नहीं मिलने पर विचार।

राज्य सरकार से तीन महीने का वेतन तथा बकाये वेतन के मद में विश्वविद्यालय को राशि प्राप्त हो चुकी है लेकिन कुलपति की उदासीनता के कारण अभी तक भुगतान नहीं हो सका है, जिसके कारण शिक्षाकर्मियों को आर्थिक कठिनाईयों का सामना करना पड़ रहा है।



Sir,

With reference to the above, I am directed to bring to your kind notice that H.E. The Governor-cum-Chancellor of Universities, Bihar has desired that the Universities be kindly advised as under :-

Functioning of the Universities should be carried out in terms of provisions of the Acts / Statutes. For this purpose, it would be important to hold the meetings of the Senate, the Syndicate, the Academic Council, the Examination Board etc. on time and as provided under the relevant Acts/Statutes. Meetings of other important decision making bodies should also be held in a timely manner.

Where there are provisions regarding nomination of Head of Department/Principal on rotation basis in Senate or Syndicate by the Hon'ble Chancellor, or in case of other nomination(s)/ approval(s), a self-contained and self-explanatory request may kindly be sent to this office well in advance to enable timely decision making at this end.

The Hon'ble Chancellor has further desired that the Universities be advised to take decision/action only in terms of what is permissible under Acts and Statutes and that no action should be taken which may be contrary to the provisions of Acts/Statutes.

Universities may kindly regularize and follow their Academic Calendar, hold examinations and publish results on time, as prescribed under the relevant provisions. Universities should also, after declaration of results, organize Convocation every year, preferably in the month of August/September. If required, sanction regarding Deemed Date may be taken from the Hon'ble Chancellor.

It is further requested that no action be taken in anticipation of approval by the Hon'ble Chancellor and proposals requiring the Hon'ble Chancellor's approval may kindly be sent well in advance, complete with all details.

Detailed letters in this regard will follow in due course.


