The Hon'ble Ms Justice Rekha M. Doshit, the Chief Justice of the High Court of Judicature at Patna and her Companion Justices of the said Hon'ble Court.

The humble application on behalf of the petitioner named above.

**MOST RESPECTFULLY SHEWETH :-**

1. That this is an application on behalf of the above named petitioners for issuance of appropriate writ(s) / Order(s) / Directions/ Directing the respondents to consider the training certificate of petitioners as recognized and also convert the session of petitioner No. 2 as 1973-1975 which was wrongly mentioned as 1983-1985 .

Further respondents be directed to consider the case of petitioners and appoint them as Assistant teacher in vacant/ sanctioned post of 2413 out of 34540 post which has to be filled up after order of Hon'ble Supreme Court.

And or pass <sup>other</sup> ~~other~~ any relief(s) as per the facts and circumstances of the case.



2. That the present writ application is inter alia based on the ground that the action of Respondents is illegal, malafide, arbitrary and also against the principles of Natural Justice. The action of Respondents not consider, the training certificate of petitioners is also clear case of non application of mind and also calourable exercise of power. The action of Respondent is violative of Article 14,16, 21 of constitution of India as well as bad in law and also in facts.
3. That the petitioners are citizens of India and residing within the territorial Jurisdiction of this Hon'ble Court.
4. That it is stated here that , petitioner No. 1 passed matriculation examination in year 1985 and took admission for Basic teacher training course in Chotanagpur Primary teachers training college Ranchin in session 1986-1988.
5. That thereafter petitioner appeared in examination and passed the same and marks sheet and certificate has

already been issued to petitioner No. 1 by the Bihar School Examination Board, Patna.

Copies of certificate/ Marks Sheet are being annexed herewith and marked as Annexure -1 and 1/a to this application.

6. That petitioner No. 2 passed Matriculation Examination in the year 1971 and thereafter took admission in Basic teacher training Course in Chotanagapur Primary Teacher Training College, Ranchi in session 1973-1975.

7. That thereafter petitioner No. 2 appeared in Examination and passed there same and Bihar School Examination Board also issued certificate / marks Sheet to the petitioner No.2.

Copies of certificate / Marks Sheet are being annexed as Annexure -2 to this application.

8. That it is stated here that the state Government published Bihar Primary Teacher Employment (Service and condition) rule 2006 in year 4, 2006.
9. That it is stated here that the petitioners being trained and applied for the post of Block Teacher / Panchayat teacher in their respective Block/ Panchayat with the certificates mentioned above and their candidature was considered on the basis of the certificates.
10. That it is stated here that petitioner No. 1 was appointed as Block Teacher in Upgraded Middle <sup>Kobahypatti</sup> Kolabaysatti Pathi Panchayat, Block Murliganj, District - Madhepura and after joining he is still working and getting his remuneration regularly.
11. That it is further stated here that petitioner No. 2 also appointed as Panchayat Teacher in New Created Primary School Barhia, Panchayat Jeetapur, Block - Murliganj, District - Madhepura and after his joining he is still working and getting salary regularly.

12. That it is relevant to state here that several cases filed before Hon'ble Supreme Court for appointment of Trained teacher in state of Bihar. Thereafter upon the direction of Hon'ble Supreme Court Mr. Justice S.K. Chattopadhyay Retired Judge of the Patna High Court was made special officer for finalization of list of trained teacher.
13. That both the petitioners belongs from the category of BC-II and initially petitioner no. 1 was placed of serial No. 34461 and thereafter he was placed as serial No. 37464 without any remarks and treating his certificate as valid and genuine.
14. That, after doing the above said exercise a merit Cum Seniority list was prepared and petitioner No. 1 name was listed at serial No. 96472 and in remarks column, the institution from which petitioner got his training certificate has been declared fake institution.

15. That it is stated here that the petitioner No. 2 also found place in merit / seniority list but his session was wrongly mentioned as 1983-1985 in place of 1973-1975 and also his institution has been declared fake institution.

16. That it is stated here that , the Secretary of Bihar School Examination Board Patna published a press Communiqué No. 26/2006 published in daily news paper Aaj on 13.11.12. in which made of same of teacher training college was mentioned whose reorganization has been cancelled . In this it has already had that reorganization of the said training college has been cancelled w.e.f. 17.3.1993.

A copy of press communique is being annexed herewith and marked as Annexure -3 to this application.

17. That it appeared from above said Annexure -3 , the institution of Petitioners are recognized till 17.3.1993 .

18. That several persons whose have passed the training from the same institution have been appointed whose name has been mentioned at serial No. 18846, 18865 and 18874 of the list.

A copy of the relevant portion of the said list is being annexed herewith and marked as Annexure -4 to this application.

19. That it is stated here that some of the candidate who have passed the training course along with Petitioner No. 1 whose name have been mentioned at Serial No. 33324, 33328, 33332, 33339, and 33345 and their institution has not been declared fake.

20. That the petitioner No.,2 found place in merit list but <sup>at Serial No-</sup> ~~1895407~~ his sessions has been mentioned as 1983-1985 in place of 1973-1975 and also his institution has been declared fake.

21. That it is further stated here that one Md. Avasar Alam whose name has been mentioned at serial No. 1420 of and his institution did not declare fake.
22. That thereafter petitioner no. 1 filed complaint before the principal Secretary Education department on 6.9.11 and requested to take appropriate action in this regard.
- A copy of application dated 6.9.11 is being annexed as Annexure -5 to this application.
23. That it is stated here that after that the petitioner No. 1 and 2 filed detail complaint before Bihar staff selection commission Bihar Patna on 18.1.12 and 29.1.12 for connection their information with regard to their training certificate but till date no action has been taken.
- Copies of complaint are being annexed as Annexure - 6 and 6/a to this application.

24. That from the abovesaid discussions it is crystal clear that the petitioners have been maliciously and malafide by debarred from the consideration Zone of the Respondent Commission due to non existent reasons.
25. That it is also pertinent to state here that earlier the Hon'ble Supreme Court has pat bar upon the Hon'ble Courts to entertain the disputes with regard to vacancy of 34540 trained teachers but vide order dated 18<sup>th</sup> of July 2013 passed in SLP ( Civil ) No. 26824 of 2012 ( Yashwant Singh and ors Vs. State of BHihar and ors. ) the Hon'ble Supreme Court modified its earlier order. The said <sup>order</sup> SLP is reported in PLJR 2013 (3) 302.
26. That so far the petitioner no. 1 is concerned his candidature has been debarred due to fake institution however others from the same session and same institution have been appointed as Assistant teachers against the 34540 vacancy.



27. That petitioner No. 2 has been debarred due to wrong entry of the session 1983-85 in place of the 1973-75 by the Respondent Commission However , persons from the session 1973-75 have got very good position.
28. That non consideration and not taking any action for appointment of petitioners against the existing vacancies by the Respondent commission is arbitrary, illegal unwarranted and also against the order of Hon'ble Apex Court.
29. That the action of Respondents is also in violation of the article 14,16 and 21 of the constitution of India as well as the Principles of Natural Justice.
30. That the petitioners are moving from pillar to post but no one is taking any action in this regard.
31. That there is not other alternative and efficacious remedy available to the petitioners then to move before this Hon'ble Court.

32 That petitioners have not moved before this Hon'ble Court earlier in this connection .

It is therefore prayed that your Lordships may graciously be pleased to allow this writ petition, issue Rule NISI calling upon the respondents to show cause and after hearing the parties make the rule absolute .

Pass such order/ orders may deem fit and proper.

And for this the petitioner shall ever pray.

लेकिन, एक बार फिर, जब 13 जुलाई, 2011 को माननीय सर्वोच्च न्यायालय में सूची सौंपी गयी तो उसमें मेरा नाम क्रमांक- 96472 पर दर्ज है लेकिन मेरे कॉलेज का नाम फर्जी कॉलेज (Fake institution) में डाल दिया गया है।
