This writ application is being filed for issuance of a writ in the nature of mandamus commanding and directing upon the respondents concerned to allow the petitioners to discharge their duties as "BALDIDI" in their respective schools as all these petitioners are working as "BALDIDI" several years and even getting their meager honorarium but suddenly in view of direction issued from the level of respondents state project Director to phase out the scheme of continuance of Baldidi in pretext of doing the same object by Aangan Bari Sevika under the I.C.D.S. of respondents state in consequent thereof concerned District level officials have stooped the payment of honorarium to these petitioners compelling them to come on road as also impugned action is contrary to the right to education to the children up to 14 years which is fundamental rights and the reason behind winding up the scheme of Baldidi in pretext of Aanganbari Sevika is arbitrary as functional and object of "BALDIDI" and Aanganbari Sevika is different to each other and for a further direction to respondents to observed the "BALDIDI" (Petitioners) against suitable posts under the

respondents state likewise non formal supervisor, Adults education instructor, census retrenched employee etc who were also facing hardship of the same kind and respondents state considering the same formulated a scheme and observed them against the suitable posts.

The petitioners are working in different school as "Balwarg didi" several years on a meager amount of Rs.500/- per month and last year the govt. has approved the increment of their honorarium to Rs. 3000/- though the 'Balwarg' Didi have demanded to be treated as govt. employee but on the pretext of Aanganbari Sevika to whom theses petitioners have give training are decided to phase out withdrawal their services.

**Facts of the case:-**

The scheme further provided for elementary childhood education (CECE) for the children in the age group of 3 to 6 years in pre-primary classes.

The petitioners nos. 2 to 6, were appointed as Bal Barg Didis at different centres under the district of Jahanabad, Muzaffarpur, Rohtas and Madhepura districts of Kaimur, District and the petitioners nos. 7 and 8 were appointed as ASRGS at Aurangabad <sup>and</sup> at Motihari places. All other centres similar appointments were made of others. All these petitioners / other fulfilled the requisite qualifications for working on such posts.

the petitioners above named.

**Most Respectfully Sheweth:-**

1. That through this writ application the petitioners pray for the following reliefs:-
  - (i) Issuance of an appropriate writ including a writ in the nature of writ of certiorari quashing the letter no. 4786 dated 19.09.12 issued by the respondent Bihar Education Project Council, through its Director ( as contained in Annexure-8) by which the respondents have intimated all the Districts Education Officers or this state that with effect from 01.12.2012 the Bal Bard Centres could not be run nor any Bal Barg Didis / ASRGS could be functional with effect from the same date, and it has further been directed that the children in the Bal Barg Centres could be placed in the Aangan Badi Centres.
  - (ii) Issuance of an appropriate writ including a writ in the nature of writ or mandamus commanding the respondents

to regularize the services of all Bal Barg Didis / ASRGS in the various centres of this state in regular services of the state if for any reason a final decision is taken to close the centres the Bal Barg Didis / ASRGS are working since quite some time and therefore this should not be put out of jobs they have been performing since the last several years.

(iii) Issuance of any other appropriate writ (s) order (s), direction (s) as may be deem fit and proper in the facts and circumstances of the case.

2. That the main grounds on which the aforementioned reliefs are prayed for are as below:-

- (a) Whether the Bal Barg Didis / ASRGS the respondents can be permitted to remove the Bal Barg Didis / ASRGS from their posts on which they have been working satisfactorily since the last several years without any complaints / adverse remarks against them.
- (b) Whether the fact that the respondents have the necessity of hands for managing and continuing with the centres, though in different form and name, can disentitle the petitioners and other Bal Barg Didis / ASRGS from claiming their services to be regularized in view of such necessity by respondents.
- (c) Whether the respondents can be permitted to adopt the policy of pick and choose in the nature of allowing some centre though in different names to remain functional and

operational and to completely close / shut down the centres where the Bal Barg Didis / ASRGS area functioning.

(d) Whether, aphorism and short term measures in various government works / functions are permissible when the government needs, hands / feds the necessity for hands on permanent basis for its various works / functions.

(e) Whether, in any view of the matter the petitioners are entitled to the relief prayed for.

3. That the petitioner nos. 2 to 8 are citizens of India all working in various Bal Barg Centres of the state as Bal Barg Didis / ASRGS. The petitioner no. 1 is are presentative body of the various Bal Barg Didis / ASRGS of this state and the petitioner no. 2 is its president.

4. That, under the ambitious Sarv Shiksha Abhiyan mooted by the Government of India various educational projects were started in the states mainly for basic education and educational developments of the under privileged and deprived sections of the society in the age group of 6-14 years and under which apart from the educational development of such people their all-round development was also comprehensively contemplated and with this aim Bal Barg Centres were decided to be opened in various places in all states. The emphasis was laid on putting all children above 6 years in schools and for making them able to attained schools the Bal Barg Centres were cost with duties for making necessary preparation and creating atmospheres conducive to education / schooling of such children. The Bal Barg Centres

were decided to be managed by Bal Didis and every Block was to have one or two Academic Support Resources Group (ASRGS).

The scheme further provided for elementary childhood education (CECE) for the children in the age group of 3 to 6 years in pre-primary classes.

The centres were decided to be run in the premises of schools and the Bal Barg Didis were to be selected in supervision of the concerned Vidyalay Shiksha Samiti that their minimum qualifications were prescribed to be matriculate. But the honorarium payable to them was kept on very low side that is the meager amount of Rs.500/-. The other details of the scheme would be elaborated at the time of hearing of the matter.

A Photo copy of the scheme in this regard is annexed herewith and marked as **Annexure-1** to this petition forming part hereof.

5. That, under this scheme the respondents opened the Bal Barg Centres at various places and appointed Bal Barg Didis for running these centres and in each Block one / two ASRGS were also appointed.
6. That the petitioners nos. 2 to 6, were appointed as Bal Barg Didis at different centres under the district of Jahanabad, Muzaffarpur, Rohtas and Madhepura districts of Kaimur, District and the petitioners nos. 7 and 8 were appointed as ASRGS at Aurangabad at Motihari places. All other centres similar appointments were made of others. All these petitioners / other

fulfilled the requisite qualifications for working on such posts. Appointment letter of petitioner no. 2 representative appointment letter and similar letters were issued to other petitioners which can be produced if required.

A Photo copy of the said appointment letter is annexed herewith and marked as **Annexure-2** to this petition forming part hereof.

7. That, the petitioners and other such appointees were also sent for training from time to time which is representative one and others were also issued such certificates which can be produced if required.

A Photo copy of the certificate of awarded in connection with training is annexed herewith and marked as **Annexure-3** to this petition forming part hereof.

8. That, the petitioners were such Bal Barg Didis / ASRGS were also issued experience certificates for the works rendered by them from time to time.

A Photo copy of the representative experience certificate is annexed herewith and marked as **Annexure-4** to this petition forming part hereof.

9. That while the petitioners have been working and performing their duties of Bal Barg Didis / ASRGS as stated above even though on paltry honorarium of Rs. 500/- per month and the respondents have been taking government works from them and the petitioners and other such appointees perform their duties works with all sincerity without hitch / hesitation for the nature of work or the meager they consider it to be duty towards societies they have been associated connected with imparting of education still the respondents instead of regularizing the services of such Bal Barg Didis and ASRGS have taken decision of discontinuing their services.
10. That the respondents have recently also taken a decision of enhancing the honorarium of the Bal Barg Didis / ASRGS with effect from 01.04.2012. The honorarium of Bal Barg Didis has been made Rs.3000/- per month and that of the ASRGS Rs. 3500/- per month.
11. That, the petitioners representative body, petitioner no. 1 on ~~Complaint~~ to know of such government decision of winding up the centres bundling out the appointees, submitted its representation dated 11.09.2012 to various representatives and the said representation also contained a list of grievances and genuine demands of Bal Bard Didis and ASRGS which include their regularization enhancement of honorarium provision of leave, regular payment of honorarium through Bank Provision for food to children and other such necessary requirements.

A Photo copy of the representation dated 11.09.2012 submitted before the Chief Minister is annexed herewith and marked as **Annexure-5** to this petition forming part hereof.

12. That, while such representation was pending consideration, the authorities at the district level started issuing letter intimating that the scheme ~~could~~<sup>could</sup> come to an end on 30.11.2012 and therefore appropriate steps be taken in this required.

A. Photo copy of said letter dated 10.09.2012 issued by the District Program Co-ordinator, Jahanabad is annexed herewith and marked as **Annexure-6** to this petition forming part hereof.

13. That, soon thereafter, the respondent Bihar Education Project Council issued letters dated 12.09.2012 and 19.09.2012 to all the District Authorities intimating that the state level meet of the District incharges had taken place and there decision was being communicated through letter dated 12.09.2012. Referring to this letter the respondent Council further issued its letter 19.09.2012 to the District Authorities intimating them that the Project Approved Board (CPAB) had decided to close down the Bal Barg Centres and not to run them from 01.12.2012 and more so because the Aanganbadi Centres were already working, and



to disengage the Bal Barg Didis / ASRGS from 01.12.2012 and to ensure payment of their honorarium up to 30.11.2012, and to ensure admission of the children of Bal Barg Centres in near by Aanganbadi Centres.

A Photo copies of said letters dated 12.09.2012 and 19.09.2012 are annexed herewith and marked as **Annexure- 7 and 8** respectively to this petition forming part hereof.

14. That soon through its letter dated 20.09.2012, the petitioner no. 1 sent representation to various authorities renewing their grievances and demands and letter was also sent through fax.

A Photo copies of the said letter dated 20.09.2012 and 26.09.2012 are annexed herewith and marked as **Annexure-9 Series** to this petition forming part hereof.

15. That, it is stated and submitted that the petitioners and other such Bal Barg Didis / ASRGS have been performing their duties most sincerely and honestly for amelioration and betterment of the children of the society without considering the money aspect which they were being meagerly paid and still the respondents have given a bloody blow to their hopes and aspirations. Instead of regularizing their services and enhancing the honorarium, the respondents have unfortunately decided to

close down the scheme and bundle out the Bal Barg Didis / ASRGS.

16. That it is stated and submitted that under similar circumstances incase of many other schemes the persons working under it were regularized in government services and they have been performing their duties with whole sincerity and demotion.

17. That, it is further stated and submitted that the government own actions depict and confirm that the government needs hands / has the necessity of hands for its scheme of Bal Barg and still to disengage the petitioners and other it has decided to close the scheme itself which is totally arbitrary and colored exercise of power.

18. That it is stated and submitted that the respondents should be appropriately directed to continue with the scheme as the object of the scheme has not yet been fulfilled nor the Aanganbari centres can substitute the Bal Barg Centres.

19. That in any view of the matter the petitioners are entitled to the reliefs prayed for.

20. That the petitioners have no other alternative and equally efficacious remedy except *moving* this Hon'ble Court on its jurisdiction.

21. That the petitioners have not earlier moved before this Hon'ble Court for the relief they seek through this petition.

22. That on the one hand the government and its agencies / instrumentalities speak about concern empowerment yet on the

other hand they were by the impugned actions of deciding to disengage the petitioners and others only reducing women empowerment and forcing them to attain zero level. This is ridiculous. This is against the announced / accepted policy. This is having political orientation. Thus, such impugned action is fit to be quashed.

23. That it is also relevant to stated that the many of the Bal Didis / ASRGS have become average for any future employment in government jobs.

24. That it is also stated that on the one hand the government has emphasized on the proper representation and huge reservation for women and on the other hand they are being firetrenched from their services and forcing them to live under starvation.

It is, therefore, prayed that your, lordships may graciously be pleased to issue Rule NISI upon the respondents asking them to show cause as to why the relief as prayed for in Paragraph – 1 above be not granted and upon return of the rule to make it absolute against the respondents and to grant the reliefs prayed for.

And

It is further prayed that during the pendency of this application, the respondents be restrained from disturbing the petitioners from their posts and should be directed to continue with the services of the petitioners until further orders.

And for this the petitioners shall ever pray.

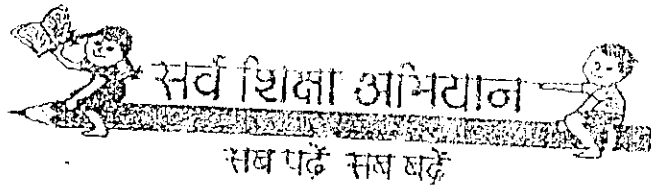

### पूर्व बालपन शिक्षा(ECE)

बच्चा राष्ट्रीय विकास की एक स्वाभाविक प्राथमिकता है। इसीलिए राष्ट्रीय बालनीति (1974) में बच्चों को राष्ट्र की सबसे महत्त्वपूर्ण परिसंपत्ति बताया गया है। राष्ट्रीय शिक्षा नीति 1986 और राष्ट्रीय कार्य-योजना 1992 में "बच्चों की देखभाल और उसकी शिक्षा" पर विशेष ध्यान देने का संकल्प लिया गया।

बाल-जीवन के प्रथम तीन से छः वर्ष विकास की दृष्टि से बहुत महत्त्वपूर्ण होते हैं खासकर 3-6 वर्ष की अवधि और भी अधिक महत्त्वपूर्ण है। इस अवस्था का जुड़ाव सीधे प्रारम्भिक शिक्षा से है क्योंकि प्रारम्भिक शिक्षा की पृष्ठभूमि इसी अवधि में तैयार होती है। बच्चे जब छः वर्ष की आयु पूरी कर प्राथमिक विद्यालयों में प्रवेश पाते हैं, तो वहाँ उनका शत प्रतिशत ठहराव तभी सुनिश्चित हो पाता है जब पूर्व में उन्हें विकास के अवसर और प्रेरक वातावरण उपलब्ध हुए हों।

कई अनुसंधान अध्ययन के निष्कर्षों से भी इस तथ्य की पुष्टि होती है कि प्राथमिक विद्यालयों में बच्चों के ठहराव और उपलब्धि स्तर पर विद्यालय-पूर्व शिक्षा का गहरा प्रभाव पड़ता है। (Study-NCERT 1992, DPEP III-2003)

शिक्षाविद् यह मानते हैं कि यदि छः वर्ष के उम्र तक बच्चों को संचक एवं रंग-विरंगे खिलौनों से भरा वातावरण मिले तो स्कूल जाने पर बच्चों में सीखने की प्रक्रिया बहुत सहज हो जाती है और वे विद्यालय में अपने आप को आसानी से समायोजित कर पाते हैं।

3-6 आयुवर्ग के बच्चों को रंग-विरंगे खिलौनों से भरपूर अनुकूल वातावरण मिले, साथ-ही-साथ बच्चों का सम्पूर्ण विकास हो, इसके लिए सर्व शिक्षा अभियान कार्यक्रम की नवाचारी शिक्षा के अन्तर्गत सभी जिलों में 140 बालवर्ग स्कूल के परिवेश में ही संचालित करने का प्रावधान है

### बालवर्ग के उद्देश्य :-

- 3-6 आयुवर्ग के सभी बच्चों को विद्यालय जाने के लिए तैयार करना।
- विद्यालय में बच्चों का ठहराव सुनिश्चित करना।
- बच्चों का खेल-खेल के द्वारा समुचित विकास करना।
- बच्चों के लिए रंग-विरंगे खिलौनों से भरपूर वातावरण सुनिश्चित करना।
- बच्चों में टीकाकरण के कोर्स को सुनिश्चित करना।
- बच्चों में आयु के अनुसार वजन एवं लम्बाई पर ध्यान देना।

### बालवर्ग की स्थापना एवं संचालन :-

- सर्व शिक्षा अभियान कार्यक्रम में विद्यालय पूर्व शिक्षा को 'बालवर्ग' के नाम से जाना जाता है।
- जिस प्रखण्ड में महिला साक्षरता दर कम हो।
- जिस प्रखण्ड के म0/प्रा0 विद्यालय में छाजन दर अधिक हो।
- वैसे म0/प्रा0 विद्यालय जहाँ विशेष रूप से बालिकाओं की छाजन दर अधिक हो।
- जिस प्रखण्ड में 3-6 आयुवर्ग के मुस्लिम एवं अनु0 जाति/जनजाति बच्चों की संख्या अधिक हो।
- बालवर्ग म0/प्रा0 विद्यालय परिसर में खोले जाएँगे।
- प्रत्येक जिले में मात्र 140 बालवर्ग ही संचालित किये जाने का प्रावधान है।
- प्रत्येक केंद्र में 25-30 बच्चे होंगे।

- बालवर्ग का संचालन प्रतिदिन तीन घंटे किया जाता है।

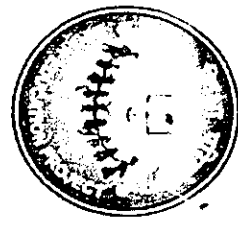


