SYNOPSIS

The petitioner runs a school in the name of Mohan Shakuntla Senior Secondary School.

The school of the petitioner got affiliation for the session 2012-14 enabling the students of the school to take up the matriculation examination to be held by the Bihar School Examination Board in the year 2014.

That despite the affiliation being granted the district education officer Madhepura is not allowing the students of the school of the petitioner to fill up the registration form.

The Bihar School Examination Board has directed the district education officer to make available the registration forms to the students of the school of the petitioner and submit it to the board but for the reasons best known to the respondent they are not releasing the registration forms to the petitioner.

The act of the respondent will cause irreparable loss and damage to the students.

MOST RESPECTFULLY SHOWETH:

- 1) That this humble application for issuance of writ of mandamus directing the respondent authorities to allow the registration of 216 students studying in Mohan Shakuntala Senior Secondary School, Madhepura.
- 2) That the petitioner is a citizen of India and resides within the territorial jurisdiction of this Hon'ble Court. The cause of action has arisen within the territorial jurisdiction of this Hon'ble Court.
- 3) That the petitioner has not moved before this Hon'ble Court seeking the same relief on any earlier occasion.

- 4) That the petitioner, Ma Shakutala Educational and Welfare Trust runs school with a missionary zeal since March 2011 with the name Mohan Shakuntla Senior Secondary School, situated at university Chowk, Madhepura.
- 5) That school was running classes from standard 1st to VIIIth under the Sarva Shiksha programme of the government.
- 6) That the students after completion of standard VIII due to the good education quality and presence of qualified teachers continued in this school and were admitted in class IXth.
- 7) That the petitioner applied for the affiliation of the school from Bihar School Examination Board in January 2012 for the session 2012-14 and deposited the required Rs. 75,000/- as the affiliation fees and Rs. 15,000/- as the inspection fees.
- 8) That the Bihar School Examination Board directed the District Education Officer, Madhepura to inspect the school and submit its report.
- 9) That with undue and unexplained delay the District Education Officer, Madhepura submitted in inspection report in the end of May, 2012.

- 10) That the inspection report showed that the school of the petitioner did not have sufficient land so as to qualify for the affiliation of the Bihar School Examination Board, Patna.
- 11) That in the interest of this school and in the interest of the students already enrolled with the school, pursuing their studies the petitioner entered into lease agreement with some land owners and thus acquired land so as to fulfil the criteria for grant of affiliation by the Bihar School Examination Board.
- 12) That it is noteworthy that there was no other deficiency or lacuna pointed by the authorities that could hinder grant of affiliation to this school of the petitioner.
- 13) That pursuant to the acquisition of land the petitioner's school completed the required criteria / standard to qualify for the grant of affiliation from the Bihar School Examination Board.
- 14) That the Bihar School Examination Board held a meeting on 12-10-2012 and granted joint affiliation for the three streams namely Arts, Science and Commerce for the session 2012-2014. Additionally, it granted joint affiliation for holding the examination of matriculation as well; accordingly letter no.

4306/D-13 dated 2-1-2013 was issued to the petitioner informing the same.

A copy of letter no. 4306/D-13 dated 2-1-2013 is annexed herewith and marked as **Annexure-1** to this application

- 15) That subsequent to this letter the Bihar School Examination Board, Patna also issued an order contained in memo no. 1551 dated 29-7-2013 listing all the schools along with the code which was granted affiliation and marked the copy to the Principals of the respective school, concerned District Education Officers, Regional Education Deputy Director and Director Secondary Education, Government of Bihar, Patna.

A copy of memo no. 1551 dated 29-7-2013 is annexed herewith and marked as **Annexure-2** to this application

- 16) That the obvious reason of issuing the above-mentioned letter and marking its copy to all the concern authorities had none other than only one intention of the Bihar School Examination Board,

that is to inform the authorities that the schools whose name appear in the list have been granted affiliation and the respective authorities should cooperate with the school administration in facilitating the registration of students and other required processes so as to enable the students to appear in the exam and to extend all possible help in conducting the matriculation examination.

- 17) That the grant of affiliation was matter of great prestige and came as a pleasure and privilege to the school administration and the students enrolled in the school of the petitioner.
- 18) That the students of the school felt secure with the affiliation as they were now, students of an affiliated school and could have lawfully and rightfully could have filled up the registration and examination form and could appear in the matriculation examinations held by Bihar School Examination Board.
- 19) That the school administration was taking extra effort in completing the syllabus in the most exhaustive manner as the school is dedicated to the education and betterment of its students.

- 20) That the school of the petitioner submitted with the Bihar School Examination Board the required fee for obtaining the registration form for the registration of students for the matriculation examination to be held by the Bihar School Examination Board in the year 2013 and obtained the receipt thereof from the Bihar School Examination Board.

A copy of the receipt of submission of fee is annexed herewith and marked as **Annexure-3** to this application

- 21) That when the school administration tried to get the students of its school registered for the examination of matriculation to be held by the Bihar School Examination Board in the year 2014 it came as a surprise to the school administration that the District Education Officer, Madhepura raised objection on such registration.
- 22) That under the process of registration for appearing in the matriculation examination held by Bihar School Examination Board, the District Education Officer has to give the registration form which is in the form of Optical Mark Reader (OMR) sheet to

the schools who distribute it among the students. The students fill up the form and submit it to the school authorities. The filled up forms are submitted to the District Education officer of the respective district who subsequently submits it to the Bihar School Examination Board.

- 23) That when the petitioner approached the District Education Officer, presented the letter of affiliation send by the Bihar School Examination Board and requested the District Education Officer to give the required number of OMR Sheet to enable the students to register themselves for matriculation examination 2014, the petitioner was surprised a taken aback as the District Education Officer, Madhepura refused to give the said OMR sheet.
- 24) That the petitioner and the entire school administration of the petitioner approached the District Education officer, Madhepura many times, showed him the letter granted affiliation for the year 2012-14 but for oblique reasons and with malice the District Education Officer, Madhepura refused to give the registration form for the school of the petitioner.
- 25) That the District Education Officer, Madhepura did similar act with other schools such as Radhe Shyam Pramod Senior Secondary

School, Maharshi Mehi Nagar, Madhepura and Geeta Ramjot Bhagat Vidya Mandir, Gopalpur, Madhepura.

- 26) That finding no other way out the present petitioner and other similarly situated schools approached the District Authorities and the Bihar School Examination Board agitating their grievances.
- 27) That Bihar School Examination Board assured the petitioner that it has granted affiliation to the school of the petitioner and there is no problem at all in registration of its students for the examination of matriculation to be held in the year 2014.
- 28) That it is noteworthy that even the District Education Officer, Madhepura sought a clarification/direction from the Bihar School Examination Board, Patna, about the present matter and the Bihar School Examination Board through its letter bearing BP2567 dated 13-9-13 informed the District Education Officer, Madhepura that the school of the petitioner has been granted affiliation for the session 2012-14 and directed the District Education Officer, Madhepura to make available the registration form to the school of the petitioner and to get the duly filled up form from the school and submit it in the office of the Bihar School Examination Board by 16-9-2013.

A copy of letter bearing BP2567 dated 13-9-13 is annexed herewith and marked as Annexure-4 to this application

- 29) That the Bihar School Examination Board informed the petitioner that it has issued the above said order directing the District Education Officer Madhepura to make available the registration form to the student of the School of the petitioner and has sent this letter to the District Education Officer, Madhepura through fax and asked the petitioner to contact the District Education Officer Madhepura and obtain the forms without any delay so that the time indicated in the letter could be adhered to.
- 30) That the petitioner approached the District Education Officer on 13-09-2013 and requested for release of the registration forms which was bluntly denied by the District Education Officer, Madhepura and his actions clearly indicated that he was looking for some unlawful consideration for such release of forms.
- 31) That the students of the school of the petitioner are legitimately entitled for registration and subsequent appearance in the

matriculation examination to be held by the Bihar School Examination Board, Patna in the year 2014.

- 32) That when the Bihar School Examination Board has granted affiliation to the school of the petitioner then the state authorities are not justified in any view of the matter in hindering the registration of the students studying in the school of the petitioner.
- 33) That it is humbly brought to the notice of this Hon'ble court that except the schools within the district Madhepura all the schools listed in Annexure 2 have been allowed to get their students registered for the matriculation examination to be held by Bihar School Examination Board in the year 2014 and no instrumentality of the state or officials of the respective district have raised any objections.
- 34) That the respondent District Officials are acting in the most arbitrary, unreasonable and uncalled for manner and even the respondent no. 3 went up to the extent of threatening the petitioner.
- 35) That the impugned course of action adopted by the respondent no. 3 is not only illegal but also risking the future of the students.

- 36) That the paramount interest of the authorities, law, parents, guardians and educational institution is the future of children and none can be allowed to take their concern, career and future in a light manner.
- 37) That there is nothing on record which can possibly restrain the students of the school of the petitioner from registration and taking the matriculation examination conducted by the Bihar School Examination Board, Patna.
- 38) That due to the rigid and unreasonable behaviour of the respondent no. 3 even the last date for submission of the registration form has expired.
- 39) That the facts brought to the notice of this Hon'ble Court, concern the future of 216 students and the students deserve the safeguard and sympathy of this Hon'ble Court.
- 40) That the petitioner has got no other equally efficacious remedy than to move before this Hon'ble Court invoking its extra ordinary jurisdiction.

It is therefore prayed that your Lordships may graciously be pleased to admit this application issue Rule

calling upon the Respondent authorities as to why the relief prayed in Para 1 of this application may not be granted to the Petitioner and after return of the Rule cause being shown and after hearing the parties the Rule may be made absolute by allowing this writ application

AND / OR

May pass such order/orders as your Lordship may deem fit and proper.

And for this, the Petitioner shall ever pray.

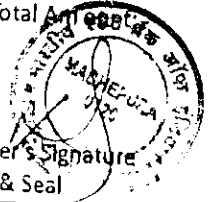
