SYNOPSIS

- 29.12.2010 Petitioner no.1^{and 3} was appointed on Urdu Teacher in Untrained Category, Urdu Primary School Rahmatganj by letter No.2^{and 3} dated 29.12.2010. Annexure-1^{and 2} 1A
- 29.12.2010 Petitioner no.2 was also appointed on the post of Panchayat Teacher in general untrained category and posted in Primary School Gopipur under Mangarwara Panchayat by the letter issued vide Memo No.6 dated 29.12.2010. Annexure-2.
- 31.12.2010 After making the appointment the petitioner and 5 other teachers has sent a letter to the Block Education Officer Kumarkhand Madhepura vide letter No.8-1 dated 31.12.2010. Annexure-3.
- 3.1.2011 For direction to the respondents for making the payment of salary of the petitioner of Panchayat Teacher since the date of joining on 3rd January, 2011 and further direction to the respondents the Headmaster of the school to allowing the petitioners to discharge his duty without any rhyme and reason.
- ~~13.1.2011~~ On 13th of ~~Jan~~ 2011 petitioners have given a representation agitating a grievance for payment of salary and given effect to the joining made by them on 3rd January, 2011. Annexure-4 and 4A.
- 8.11.2011 In spite of discharging the duty and not allowed to mark the attendance not being paid the salary their condition was has become worst on 8th of November, 2011. Annexure-5 and 5A.
- 17.4.2012 Petitioners running from pillar to post on 17th April, 2012 they have filed the representation to the District Magistrate. Annexure-6.

Hence the writ application is being filed.

The Hon'ble Ms. Justice Rekha M. Doshit the Hon'ble Chief Justice of the High Court of Judicature at Patna and his companion justices of this Hon'ble Court.

The humble petition on behalf of the petitioners named above.

MOST RESPECTFULLY SHEWETH

1. That this is an application for issuance of an appropriate writ order or direction to the respondents for making the payment of salary of the petitioner of Panchayat Teacher since the date of joining on 3rd January, 2011 and further direction to the respondents the Headmaster of the school to allowing the petitioners to discharge his duty without any rhyme and reason is not allowing the petitioners as taking into circumstance the respondent no.13 namely Pankaj Kumar was also appointed along with petitioners have been allowed to discharge the duty and his getting salary since he was the nephew of the then B.D.O.Kumarkhand and representation filed by the petitioners before the B.E.O. Kumarkhand and District Programme Officer Madhepura is pending till this date no decision has been taken.

2. That points for consideration of the present writ application are as follows:-

- (i) Whether the Headmaster of the school respondent No.9 and 10 can sit over the matter of the appointment and not allowing to discharge the duty resulting therein nonpayment of salary?
- (ii) Whether the action of the respondent authorities without assigning any reason this allowing the petitioner the payment of salary and the duty of the post of Panchayat Teacher on which they were duly appointed by the competent authority?
- (iii) Whether the respondents can be justified in giving the salary and due to the respondent no.13 who is similarly situated and appointed along with the petitioners?
- (iv) Whether the action of the respondents are arbitrary the grievance raised by him has sit over the matter and not taking any steps in this regard?
- (v) Whether the action of the respondents are violative of Article 14, 16 and 21 of the Constitution of India?

3. That petitioners are citizen of India residing within the territorial jurisdiction of this Hon'ble Court.

4. That after coming into force of Bihar Panchayat Primary Teachers Rules, 2008 process has been started for filling of the post of Panchayat Teacher and accordingly the Mangarwara Gram Panchayat under Block-Kumarkhand within the District of Madhepura and as per the vacancy and roster of reservation provided by District Magistrate Madhepura the appointment committee Mangarwara Gram Pacnahayt invited the applications accordingly in pursuance of that petitioners have applied.

5. That petitioners are in untrained category so as per their merit position the counseling was done and 7 Panchayat Teachers were appointed in Mangarwara Gram Panchayat and the appointment letters were issued to the petitioners the petitioner 1 and 3 was appointed on Urdu Teacher in Untrained Category, Urdu Primary School Rahmatganj by Letter No.2 &3 dated 29.12.2010 and they were directed to give consent before the Panchayat Secretary and as also give the joining in the concerned school within 10 days in pursuance of that appointment letter Petitioner No.1 and 3 has given their

~~in~~

consent letter to the Panchayat Secretary and given his joining on 3rd of January, 2012 before the Headmaster of the school.

A photo copy of the Appointment Letter issued vide Memo No.2 and 3 dated 29.12.2010 is annexed herewith and marked as **Annexure-14/A** to this writ application.

6. That similarly petitioner no.2 was also appointed on the post of Panchayat Teacher in general untrained category and posted in Primary School Gopipur under Mangarwara Panchayat by the letter issued vide Memo No.6 dated 29.12.2010, she was also directed to give her consent to the said appointment and make her joining. In pursuance of that petitioner no.2 has also submitted her consent and given her joining before the Respondent No.10 the Headmaster of the School on 3.1.2011.

A photo copy of the appointment letter bearing Letter No.6 dated 29.12.2010 is annexed herewith and

marked as **Annexure-2** to this writ application.

7. That after joining in the said school petitioners started discharging their duty but the attendance was not being made but they were not allowed to make the attendance on query the Headmaster has told unless approval to the appointment from the Block Education Officer will not come they will not be allowed to mark the attendance.

8. That it will be also relevant to brought in the notice of this Hon'ble Court the Panchayat Secretary of Mangarwara Gram Panchayat after making the appointment the petitioner and 5 other teachers has sent a letter to the Block Education Officer Kumarkhand Madhepura vide Letter No.8-1 dated 31.12.2010 giving the copy to the Block Development Officer Kumarkhand informing therein as against the vacancy notified by the District Magistrate Madhepura in Mangarwara Gram Panchayat the appointments were made on the post of Panchayat Teacher and details were given in the said letter name of petitioner No.1 & 3 at Sl.No.2 & 3 on the post of Urdu EBC category and petitioner No.2 at Sl.No.6 on the post of General Teacher in BCF category and name of respondent no.13 has been shown at Sl.No.5 in General Teacher under unreserved category and further request has been made to do the further steps.

A photo/type copy of Letter No.8-1 dated 31.12.2010 is annexed herewith and marked as **Annexure-3** to this writ application.

8. That petitioners continued in the school discharging their duty but the ~~same~~^{salary} was not being paid to them only on the ground since no letter has been received from the Block Education Officer so the attendance will not be mark by them on attendance register at the same time petitioner has got the information the respondent No.13 namely Pankaj Kumar who happens to be the nephew of the B.D.O. Kumarkhand he was allowed to mark the attendance and salary was also being paid to them on 13th of July, 2011 petitioners have given a representation agitating a grievance for payment of salary and given effect to the joining made by them on ^{13th} 3rd January, 2011.

10. That since the authorities have not taken any steps only on the ground the petitioners could not be obliged by the B.E.O. Kumarkhand who are sitting over the matter finding no way since in spite of discharging the duty and not allowed to mark the attendance not being paid the salary their condition has become worst on 8th of November, 2011. They have filed a representation to the District Programme Madhepura to look into the matter since in spite of appointment and joining the Headmaster of the school Respondent No.9 and 10 is ill-motivated along with the B.E.O. Kumarkhand since they were not able to oblige them the marks they are not being allowed to make attendance and even the duties are not being given to them due to that in absence of salary they are on the verge of starvation.

11. That petitioners running from pillar to post on 17th April, 2012 they have filed the representation to the District Magistrate ventilating their grievance but till this date nothing has been done neither they have cancelled their appointment nor rejected the claim and matter is pending.

A photo copy of the representation dated 17.5.2012 is annexed herewith and marked as **Annexure-6** to this writ application.

12. That it is submitted that here the competent authority for making the appointment on the post of Panchayat Teacher is the appointment Committee the Gram Panchayat and bare perusal of Annexure-1, 2 and 3 as per the decision of the Niyozan Committee of Mangarwara Gram Panchayat against the appointment process started petitioners were appointed along with others and the Respondnt No.13 was one of the appointee who is being allowed his duty and salary since he was the nephew of the B.D.O. of the Block

but in the case of petitioners', authorities are sitting over the matter and they are running from pillar to post and till this date no order has been issued why they will not allowed to discharge the duty and in pursuance of appointment the payment of salary but not paid to them. It is further submitted due to arbitrariness of the Block Education Officer and respondent No.9 and 10 petitioners are on the verge of starvation.

13. That finding no other way an efficacious remedy than to move this Hon'ble Court petitioners are filing the present writ application for redressal of his grievance.

13. That petitioners have not moved earlier before this Hon'ble Court in the matter of present writ application.

It is, therefore, prayed that your lordships may be graciously pleased to issue rule NISI calling upon the respondents to show cause as to why the prayer made in Paragraph No.1 be not allowed and on return of the rule hearing the parties the same be made absolute.

And/or

Pass such other order or orders as your lordships may deem fit and proper and proper and in the facts and circumstances of the case.

And for this I shall ever pray.
