MOST RESPECTFULLY SHEWETH:

1. That this is an applications on behalf of abovenamed petitioners for issuance of appropriate writ (s) / Order(s) /

Direction(s) for appropriate direction to the Respondents Staff Selection Commission to consider and correct the remarks column of merit list for the validity of the Institution and thereafter to consider and appoint the petitioner against existing vacancy of 2413 out of 34540.

And or any other relief(s) as per the facts and circumstances of the case.

- 2. That declaration of petitioner's institution as fake by the respondent staff selection Commission is illegal, malafide, arbitrary and also without any basis. The Action of respondent is violative of Article 14,16 and 21 of Constriction of India as well as Principal of Natural Justice.
- 3. That the petitioner is citizen of India and residing within the territorial Jurisdiction of this Hon'ble Court.
- 4. That it is stated here that petitioner passed the matriculation in year 1988 and took admission non government Chhotanagarpur Primary Teachers Training

College Doranda, Ranch in Session 1988-1990 it is hereby pertinent to state here that the said institution was validly recognized by the state Government as well as other authorities for the said period.

5. That thereafter petitioner appeared in examination and passed the same 2nd division and marks sheet and certificate has been issued by the Bihar School Examination Board, Patna.

Copies of marksheet and certificate are being annexed as Annexure -1 series to this application.

- 6. That on the basis of said basic teacher training certificate petitioner is still working as trained teacher in new Created Primary School Malik Tola Rajni Block Murliganj, District Madhepuar.
- 7. That it is pertinent to state here that several case filed before Hon'ble Supreme Court for appointment of

Trained Teacher in state of Bihar. Thereafter direction of Hon'ble Supreme Court Mr.S.K. Chattopadhya the Retired Judge of Patna High Court made Special officer for finalization of list of trained teacher.

- 8. That after doing the above said exercise merit list prepared and published in which petitioner shown at Serial No. 97325 but in the remarks column his institution was declared as fake.
- 9. That petitioner got shocked and surprised when he saw his name in the merit list with a remarks as fake institution simultaneously the respondent commission has treated the institution as valid and recognized for the aforesaid session for other candidates. Petitioner has obtained information about some of them which are being given here with one. Asha Kumari and Parash Nath Yadav who have been placed at Serial No. 48072 and 45447 in the same session of 1988-1990 has been treated as valid and recognized in fact there are more than

hundred of candidates having teacher training certificat from the institution in question and with same session has been declared valid candidates.

10. That the petitioner filed his complaint before Bihar Staf Selection Commission Patna on 13.01.2012 with all documents and ground of validity of institution. But il date no correction has been made by the respondne commission in this regard.

A copy of compliant dated 13.01.12. is Annexed as Annexure -2 to this application.

- 11. That training certificate of the petitioner issued by Bihar School Examination Board is being treated in valid and recognized certificate for every where and all peruses.
- 12. That it is also pertinent to state here that earlier the Hon'ble Supreme Court has put ban upon the Hon'ble Courts to entertain the disputes with regard to vacancy of 34540 trained teachers but vide order dated 18th of July

- 2013 passed in SLP (Civil) No. 26824 of 2012 (Yashwant Singh and ors Vs. State of Bihar and ors.) the Hon'ble Supreme Court modified its earlier order. The said SLP is reported in 2013 (3) PLJR 302.
- 14. That if the correction will be made in the merit panel of the petitioner he will come under the consideration Zone for appointment against the vacancy of B.C. II category.
 - 15. That the action of respondent is illegal, arbitrary, Malafide, malacious and bad in law and also in facts.
 - 16. That the action of respondent is violative of Article 14,16 and 21 of Constitution of India and as well as Principles of Natural Justices.
 - 17. That the petitioner has no other efficacious and alternative remedy except to move before this Hon'ble Court.
- 18 That the petitioner has not moved earlier before this Hon'ble Court in the matter.

Lordships may graciously pleased to issue Rule NISI callinupon the respondents as to why the prayer made in Paragraph No. 1 this petition be not allowed to the petitioner and on return of Rulhearing in parties the same be made absolute and pass order, orders a your Lordships may deem fit an proper.


