SYNOPSIS

**Prayer:-** This application is to issue appointment letter in favour of petitioner for her appointment as Primary Teacher within the District of Madhepura in pursuant to the order passed by the Hon'ble Supreme Court of India in SLP(C) No. 22882/2004 whereby and where under the Hon'ble Supreme Court has been pleased to direct the State Government of Bihar to advertise 34540 seats for appointment of Assistant Teachers.

Facts of the Case

The facts of the case is that the petitioner Babita Kumari has passed matric exam and also passed Teacher's training form from M. K. F. W. Primary Teachers Training College (Miliya Kaniza Fatima Women Primary Teachers Training College), Rambagh, Purnia and had applied for Primary Teacher as per the advertisement published by the Government of Bihar. Her name was also mentioned in the Sl. No. 34368 in the First Merit List and Sl. No. 31334 in the Second Merit List but the name of the petitioner has not been mentioned in the Third Merit / Gradation List but placed at Sl. No. 96254 on account of non-appointment of the

petitioner on the ground of Institution of the Petitioner shown to be un-recognized/fake whereas from the same very Institution the other candidates have been found eligible.

- Year 2003      Advertisement made by the Bihar Government for 34540 seats for appointment of Assistant Teachers.
- 25.01.2012      Objection petition filed by the petitioner Nutan Kumari
- 31.07.2012      Representation filed by the petitioner Nutan Kumari before the Respondents authority no. 2, 3 and 5.

the petitioner named above.

Most respectfully sheweth :-

- 1) That the petitioner of this case file this writ application for grant of the following reliefs :-
  - (i) For issuance of writ/writs, order/orders, direction/directions in the nature of writ of mandamus commanding the respondent authorities to issue appointment letter in favour of petitioner for

her appointment as Primary Teacher within the District of Madhepura in pursuant to the order passed by the Hon'ble Supreme Court of India in SLP(C) No. 22882/2004 whereby and where under the Hon'ble Supreme Court has been pleased to direct the State Government of Bihar to advertise 34540 seats for appointment of Assistant Teachers.

- (ii) For further direction to the respondent authorities to immediately issue the appointment letter in name of the petitioner while the petitioner has passed the teacher training (trained teacher) from M. K. F. W. Primary Teachers Training College (Miliya Kaniza Fatima Women Primary Teachers Training College), Rambagh, Purnia while the petitioner has been trained from this institution and has been shown to be the recognized institution but the Respondent authorities have made claim that the aforesaid institution have been shown to be unrecognized/ fake, whereas from the same institution the other candidates have been found eligible and have been appointed but this petitioner has not been appointed by the Respondent Authorities.

(iii) For further prayer for the petitioner to direct the respondents authorities to consider the objection petition which has already been filed by the petitioner before the Bihar Staff Selection Commission, Patna for consideration of the status of the petitioner status of her institution in respect of which the objection has already been filed by the petitioner but the aforesaid objection petition has not been considered by the Respondent Authorities while the petitioner is a candidate of Primary Teacher and the objection petitioner has been filed by the petitioner within time i.e. on 25.01.2012 before the Respondent no. 2, 3 and 5.

(iv) For further prayer for the petitioner to pass any other relief/reliefs, order/orders, direction/ directions as may deem fit and proper in the facts and circumstances of this case.

2) That the petitioner is a citizen of India and ordinary resided of District Madhepura within the territorial jurisdiction of this Hon'ble Court.

3) That the moot question of law besides others arises for consideration to this Hon'ble Court are as follows :-



(a) Whether the action of the respondents is not illegal mala-fide and discriminatory so that the petitioner being a bonafied candidate for the Assistant Teacher as she has passed Teachers Training from M. K. F. W. Primary Teachers Training College (Miliya Kaniza Fatima Women Primary Teachers Training College), Rambagh, Purnia in Session – 1986-1988 and the date of birth is 10.06.1970.

Whereas the petitioner after obtaining Teacher's training degree from the aforesaid institution she had applied for appoint in advertisement no. 210/2010 published by the State of Bihar for 34540 seats for appointment of Assistant Teachers and the matter of the appointment of the Assistant Teachers ultimately transferred up to the Hon'ble Supreme Court of India vide SLP(C) No. 22882/2004 arose out of alleged breach of undertaking said to have been filed by the State of Bihar and the order has been passed by the Hon'ble Supreme Court on 23<sup>rd</sup> January, 2006, while the undertaking said to have been given on 18.01.2006 by the Hon'ble Supreme Court of India in SLP(C) no. 22882/2004.

Whereas the Hon'ble Supreme Court of India has been pleased to passed the aforesaid order on 19<sup>th</sup> January, 2009 when a number of writ applications have been filed against the State of

Bihar raising issued relating to the appointment of teachers of Primary Schools at one stage on account of change in the policy, who were in place at the time when the undertaking were given by the State of Bihar. But the petitioner has not been appointment while the name of the petitioner has been mentioned in gradation (merit) lists. In the first gradation(merit) list with Serial Number as 34368 and in the second gradation(merit) list at Sl. No. 31334 but in the third and final gradation (Merit) list the name of the petitioner has been deleted and only Ll. No. 96254 which is mentioned as fake institution. Thereafter the petitioner had made objection petitioner T-22993 dated 25.01.2012 before the Bihar Staff Selection Commission Patna in spite of that the petitioner has not been appointed. Such action of the Respondent Authorities have not illegal?

(b) Whether the name of the petitioner which is mentioned in the First Gradation (Merit) List at Sl. No. 34368 and in the Second Gradation (Merit) List at Sl. No. 31,334 but in the Third Gradation (Merit) List which as issued by the Respondent Authorities only Sl. No. 96254 which has been mentioned as Fake Institution, whereas the other candidates of the same Institution have been found

eligible but the petitioner's name has been found by the Respondent Authorities that her institution have been shown to be un-recognized/fake. Such action of the Respondent Authorities is not illegal mala-fide and discriminatory?

4) That the present Writ application may be passed on the following **Grounds** :-

- a) For that the Respondent Authorities are not legally justified in not appointing the petitioner as a Primary Teacher.
- b) For that non-appointment of the petitioner is against the gross violation of the directions issued by the Hon'ble Supreme Court of India.
- c) For that once the name of the petitioner has been approved by the Hon'ble Supreme Court there is no legally impediment in the appointment of the petitioner as Primary Teacher.
- d) For that the Hon'ble Supreme Court has categorically held with Rules framed by the State Government shall be deemed to have been modified to the extent of the direction and order issued by the Hon'ble Supreme Court of India.

- e) For that no information have been provided to the petitioner by the Respondent Authorities for her non-appointment as Primary Teacher
- f) For that the name of the petitioner was duly sent by the State Government recommended by the committee duly constituted under the order of the Hon'ble Supreme Court and finally approved by the Hon'ble Supreme Court in exercise their power for appointment of 34540 seats for the post of Assistant Teachers and name of the petitioner was mentioned in the Merit lists i.e. in the First Merit List at Sl. No. 34368 and in the Second Merit List at Sl. No. 31,334 but in the Third Merit List the name of the petitioner has been deleted having without given any information to the petitioner.
- g) For that the petitioner has been subjected to hostile discrimination since the Respondent Authorities have appointed the candidates similar to the petitioner but had denied the same to the petitioner and no reason has been mentioned and without giving any information to the petitioner for their non-appointment as Primary Teacher.

h) For that the action of the Respondent Authorities is violating the Article 14 and 16 of the Constitution of India.

5) That short facts of the case is that the petitioner has passed Matriculation Examination of the Bihar School Examination Board, Patna in the year 1985.

A photocopy of the Matriculation Certificate is hereby annexed and marked as Annexure- 1 to this writ application.

6) That the petitioner has passed the Teacher's Training in Session – 1986-1988 from M. K. F. W. Primary Teachers Training College (Miliya Kaniza Fatima Women Primary Teachers Training College), Rambagh, Purnia.

A photocopy copy of the teacher training certificate is hereby annexed and marked as Annexure- 2 to this writ application.

7) That in the year 2003 the State of Bihar advertised 34540 seats for appointment of Assistant Teachers and the matter of the appoint

of 34540 teachers ultimately travelled up to the Hon'ble Supreme Court of India vide SLP(C) No. 22882/2004.

8) That in the order of the Hon'ble Supreme Court of India a committee was constituted which recommended the settled list of Trained Teachers to be appointed. A list duly settled by the committee was placed before the Hon'ble Supreme Court and the Hon'ble Supreme Court approved the Roster as well as seniority list. The said list approved by the Hon'ble Supreme Court was sent to the Government of Bihar for implementation.

9) That thereupon the selection process was initiated by the State of Bihar. The petitioner as per the said Merit List and other qualified candidates were called for counseling and the petitioner appeared for counseling and subsequently all the persons found eligible for appointment as per the roster and were allotted the districts of posting. The petitioner was allotted the District of Madhepura and thus the petitioner's name was shown in Zila List with fully details of the petitioner and also stated her respective training session. But subsequently the name of the petitioner has been deleted by the Respondent Authorities in the Third Merit List having without any

information and without any hearing of the petitioner on the point of non-appointment of the petitioner for their said post.

10) That general notice was published in the signature of the Respondent Authority whereby it has been intimated that any candidate who has made any claim for appointment as Assistant Teacher, then like petitioner, are required to file their objection petition before the Bihar Staff Selection Commission, Patna as well as before the authorities concerned. Accordingly, the petitioner filed an objection petition on 25.01.2012 before the Respondent no. 5 but the same has not been considered and no information has been given to the petitioner for non-appointment of the petitioner on the post of Primary Teacher.

A photocopy/ true type copy of the objection petition dated 25.01.2012 is hereby annexed and marked as Annexure- 3 to this writ application.

11) That the petitioner has also filed by way of Representation before the Respondent Authorities no. 2, 3 and 5 on 31.07.2012 and has made request for consider the objection petition dated 25.01.2012 but without consideration of the objection petition filed by the petitioner she

has not been appointed on the post of Primary Teacher the reason best known to them.

Photocopies/ true type copies of the representation filed by the petitioner dated 31.07.2012 are hereby annexed and marked as Annexure- 4, 4A in series to this writ application.

- 12) That when the petitioner was not appointed she met with the authorities concerned with folded hand and has made request them for providing her appoint letter but the same has not been considered by the Respondent authorities.
- 13) That it is also relevant to mention here that till date no communication has been made by the Respondent Authorities to the petitioner showing reasons for non-provided her appointment letter, the petitioner has perused the matter before the Appointment Authorities but no reason has been given for non-providing of the appointment letter and the respondent authorities are keeping mum over the issue.
- 14) That the action of the Authority concerned for non-issuing the appointment letter to the petitioner despite specific order/direction of



the Hon'ble Apex Court is illegal, mala-fide un-just, discriminatory and against the principle of natural justice.

15) That the name of the petitioner has been mentioned in First and Second Merit/Gradation List prepared by the Respondent Authorities as Sl. No. 34368 in the First Merit List and Sl. No. 31334 in the Second Merit List but the name of the petitioner has not been mentioned in the Third Merit / Gradation List but placed at Sl. No. 96254 on account of non-appointment of the petitioner on the ground of Institution of the Petitioner shown to be un-recognized/fake whereas from the same very Institution the other candidates have been found eligible therefore, the case of the petitioner, which is exact similar to the other candidates who were appointed on the post of the Assistant Teacher.

Photocopies/ true type copies of the First, Second and Third Gradation Lists are hereby annexed and marked as Annexure- 5, 5A in series to this writ application.

16) That there is no officious and alternate remedy except to file this writ application for redress of her grievances before this Hon'ble Court.

17) That the petitioner has earlier has earlier not moved for grant of any writ petition presently to this Hon'ble Court for relief / reliefs sort for in this writ application.

It is, therefore prayed that Your Lordships may graciously be pleased to admit this writ application issue rule nisi calling upon the respondents to show cause, if they appear, as to why the reliefs shown in paragraph – 1 to this writ application be not granted in favour of the petitioner and such other rule if shown any after hearing benefit to please allow and make the same absolute.

And/or

Pass such other order or orders as your lordships may deem fit and proper.

And for this the petitioner shall ever pray.
