CHRONOLOGICAL FACTS & SYNOPSIS

That the instant Writ Application is being filed for issuance of appropriate Writ/Writs, Order/Orders, Direction/Directions commanding the Respondents concerned to ensure joining of the Petitioner at Bhagalpur on the post of Primary Teacher in view of the fact that he was placed at Serial No. – 19303 of final selection list prepared in compliance of the order of Hon'ble Supreme Court of India and as such legally entitled for appointment and joining on the aforesaid post and for other reliefs as prayed in Paragraph – 1 of the application.

12/07/2010 (ANNEXURE – 1 / PARAGRAPH – 4)

Petitioner submitted his application for appointment on the post of Primary Teacher vide speed post on 12/07/2012 against Advertisement No. – 210/10 of the Staff Selection Commission, Bihar.

12/08/2010 (ANNEXURE – 4 / PARAGRAPH – 6)

Petitioner in reference to the Advertisement No. – SSC-210/2010 has submitted his application for district option on 12/08/2012 in priority order as 1. Bhagalpur, 2. Banka & 3. Munger.

31/12/2010 (ANNEXURE – 2 & 3/ PARAGRAPH – 5)

An integrated session wise seniority list of Primary Teachers was published, where the Petitioner was placed at Serial No. – 44253 but the address of the Petitioner was mentioned incorrect at the relevant place in the said list and accordingly the Petitioner immediately on 31/12/2012 submitted application before the Secretary, Bihar Staff Selection Commission, Patna vide Speed Post for correction in the same.

30/01/2012 (ANNEXURE – 6 / PARAGRAPH – 8)

Objections were invited by the Respondent No. – 4 and accordingly the Petitioner filed his objection with regard to the incorrect address on 30/01/2012, which has been allotted as Objection No. – T-40615.

02/02/2012 (ANNEXURE – 8 / PARAGRAPH – 10)

Petitioner was denied for counselling at Madhepura on 02/02/2012 by the District Program Officer (Establishment)-cum-Counselling Officer, Madhepura on the ground that the application, photograph and some of the certificates of the Petitioner was not matched with the official record. Further, the Petitioner on the same day represented the matter to the Respondent No. – 5 for needful action in the matter.

06/02/2012 (ANNEXURE – 9 / PARAGRAPH – 11)

District Education Officer (Madhepura) i.e. the Respondent No. – 6 has asked for guideline in the matter from the Director, Primary Education i.e. Respondent No. – 3 vide Letter No. – 76 (Uchch) dated 06/02/2012 stating about the difference in photograph, roll code of matriculation examination and training certificate (although the roll no. and roll code were same) of the Petitioner.

Petitioner thereafter represented the matter to all the concerned authorities for redressal of his very legitimate and genuine grievances but all went in vein and the Petitioner has yet not been appointed on the post of Primary Teacher for which he undisputedly qualified and **HENCE THIS WRIT APPLICATION.**

MOST RESPECTFULLY SHEWETH: -

1. That the instant Writ Application is being filed for the following reliefs: -
 - (i) **FOR** issuance of appropriate Writ/Writs, Order/Orders, Direction/Directions commanding the Respondents concerned to ensure joining of the Petitioner at Bhagalpur on the post of Primary Teacher in view of the fact that he was placed at Serial No. -- 19303 of final selection list prepared in compliance of the order of Hon'ble Supreme Court of India and as such legally entitled for appointment and joining on the aforesaid post.

- (ii) **FOR** issuance of Direction/Directions to the Respondents concerned to immediately ensure joining of the Petitioner on the post of Primary Teacher at Bhagalpur as he has opted for posting in the home district but it apparently appears that the Respondent No. – 7 in collusion with the Respondent No. – 4 has illegally made tampering in the application, photograph, certificate and address of the Petitioner for his appointment by illegal means.
- (iii) **FOR** issuance of appropriate Order/Orders, Direction/Directions to the Respondents concerned to initiate appropriate and adequate criminal proceeding against the Respondent No. – 7 and erring officials/staffs of the Respondent No. – 4 for the criminal act they have done in order to make illegal appointment of Respondent No. – 4 using and tampering the certificates and qualifications of the Petitioners.
- (iv) **FOR** any other relief/reliefs for which the Petitioner is entitled under law.

2. That the following substantial questions of law are involved in the instant Writ Application: -

- (i) **WHETHER** the actions of the Respondents concerned are illegal, arbitrary, unconstitutional, malafide and a colourable exercise of power in not allowing the Petitioner in counselling and not made him joined on the post of Primary Teacher at Bhagalpur although his name with other details figured in the final selection list prepared in compliance of the order of Hon'ble Supreme Court of India?

- (ii) **WHETHER** the actions of the Respondents are against the provisions of Article – 14, 16 and 21 of the Constitution of India in debarring the Petitioner from his employment which he is legally entitled on merit fulfilling all the criterias, which otherwise he may have got if there were no illegal activities by the Respondent No. – 7 and some of the officials/staffs of the Respondent No. – 4?
- (iii) That the other substantial questions of law will be by way of submissions to this Hon'ble Court.
3. That the Petitioner is a citizen of India and resides within the territorial jurisdiction of this Hon'ble Court.
4. That the Petitioner submitted his application for appointment on the post of Primary Teacher vide speed post on 12/07/2012 against Advertisement No. – 210/10 of the Staff Selection Commission, Bihar fulfilling all the criterias given therein alongwith all the requisite documents.
- For clarity and brevity, photocopy of the postal receipt dated 12/07/2012 is annexed herewith and marked as **ANNEXURE – 1** to this application.
5. That on the aforesaid basis an integrated session wise seniority list of Primary Teachers was published, where the Petitioner was placed at Serial No. – 44253 but the address of the Petitioner was mentioned incorrect at the relevant place in the said list and accordingly the Petitioner immediately on 31/12/2012 submitted application before the

Secretary, Bihar Staff Selection Commission, Patna vide Speed Post for correction in the same.

For clarity and brevity, photocopy of the seniority list and application dated 31/12/2010 are annexed herewith and marked as **ANNEXURES - 2 & 3** to this application.

6. That the Petitioner in reference to the Advertisement No. – SSC-210/2010 has submitted his application for district option on 12/08/2010 in priority order as 1. Bhagalpur, 2. Banka & 3. Munger. It is pertinent to mention here that the Petitioner never opted for District – Madhepura.

For clarity and brevity, photocopy of the application dated 12/08/2010 is annexed herewith and marked as **ANNEXURE - 4** to this application.

7. That in compliance of the order of Hon'ble Supreme Court of India, a final selection list of 34,540 has been published in which the Petitioner has been placed at Serial No. – 19303.

For clarity and brevity, photocopy of the final selection list is annexed herewith and marked as **ANNEXURE - 5** to this application.

8. That thereafter objections were invited by the Respondent No. – 4 and accordingly the Petitioner filed his objection with regard to the incorrect address on 30/01/2012, which has been allotted as Objection No. – T-40615 by the Bihar Staff Selceton Commission, Patna.

For clarity and brevity, photocopy of objection dated 30/01/2012 is annexed herewith and marked as **ANNEXURE – 6** to this application.

9. That inspite of the earlier application for option of choice district as Bhagalpur, Banka and Munger, several representations regarding correction in address and objection dated 30/01/2012, the Petitioner has been allotted district Madhepura for counselling and appointment for the reasons best known to the concerned Respondents.

For clarity and brevity, photocopy of the counselling list is annexed herewith and marked as **ANNEXURE – 7** to this application.

10. That the Petitioner was denied for counselling at Madhepura on 02/02/2012 by the District Program Officer (Establishment)-cum-Counselling Officer, Madhepura on the ground that the application, photograph and some of the certificates of the Petitioner was not matched with the official record. Further, the Petitioner on the same day represented the matter to the Respondent No. – 5 for needful action in the matter.

For clarity and brevity, photocopy of the representation dated 02/02/2012 is annexed herewith and marked as **ANNEXURE – 8** to this application.

11. That the on the basis of the aforesaid representation of the Petitioner, the District Education Officer (Madhepura) i.e. the Respondent No. – 6 has asked for guideline in the matter from the Director, Primary Education i.e. Respondent No. – 3 vide Letter No. – 76 (Uchch) dated 06/02/2012 stating about the difference in photograph, roll code of matriculation examination and training certificate (although the roll no. and roll code were same) of the Petitioner.

For clarity and brevity, photocopy of the Letter No. – 76 (Uchch) dated 06/02/2012 is annexed herewith and marked as **ANNEXURE – 9** to this application.

12. That the Petitioner thereafter inquired the matter at his own by various sources as well as invoking the provisions of the Right to Information Act, where he found that his application, photograph and documents were tampered/changed by the Respondent No. – 7 i.e. one Upendra Mandal in collusion with the some of the officials/staffs of the Respondent No. – 4 for illegal gains in a illegal way.
13. That the Petitioner thereafter represented the matter to all the concerned authorities for redressal of his very legitimate and genuine grievances but all went in vein and the Petitioner has yet not been

appointed on the post of Primary Teacher for which he undisputedly qualified.

14. That the Petitioner has no other equal and efficacious remedy rather than to file the present Writ Application before this Hon'ble Court.
15. That the Petitioner has not moved earlier in the matter before this Hon'ble Court for similar reliefs.

It is, therefore, prayed that your lordships may graciously be pleased to issue **RULE NISI** and after the show-cause if any, or after hearing the parties be pleased to allow the reliefs as prayed for vide Paragraph – 1 of this Writ Application

Pass such other order / orders, which may be deemed fit and proper.

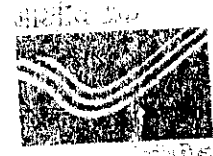
