The Hon'ble MS Justice Rekha. M Doshit , the Chief Justice of the Hon'ble High Court of Judicature at Patna and her companion Justices of the said Hon'ble Court .

The humble petition on behalf of the petitioners above named :-

**Most Respectfully Sheweth**

1. That by this writ application , the petitioners seek indulgence of this the Hon'ble High Court for issuance of an appropriate writ for the following reliefs :-  
  - (i) To direct the respondent No. - 2 Deputy Collectors Land Reforms Uda- Kishunganj, Distt – Madhepura to pass the order in Mutation case No-54 /11 - 12 ,55 / 11-12 , & 56/11-12 without any further delay as per law & merit of the case.
  - (ii) To direct the respondent No. - 2 Depty Collectors Land Reforms Uda Kishunganj , Distt – Madhepura to inspect

the plots himself and call for the entries of records from the Circle Officer Bihariganj related to this case & after verifying the records passed the order.

- (iii) To direct the respondent No. - 2 Deputy Collectors Land Reforms Uda -Kishunganj not to sit over the matter for indefinite period . Which causes annoyance.
  - (iv) To grant any other relief / reliefs as to which the petitioners are entitled in the facts and circumstances of the case.
2. That the petitioner is a citizen of India.
- 3 The the main points of law arises for consideration of this Hon'ble Court as follows.
- (i) Whether the order dated 03.03.2011 , 25.10.2010 & 16.10.2009 passed by the respondent no- 3 Circle Officer ,Bihariganj in Mutation case no- 3545,1160 & 3495 without verifying the entries in records of right, is justified ?
  - (ii) Whether the order passed by the respondent no-3 in different mutation case above said without following the procedure laid down by the State Govt. time to time , is justified ?
  - (iii) Whether the act of the respondent no -3 Circle Officer, Bihariganj without going into the entirety of the title, interest & possession over the land, is justified ?
  - (iv) Whether the act of the respondent no -2 Deputy Collector Land Reforms, Uda kishunganj is not unjust & improper to

delay the mutation Appeal . Which is pending for about two years is justified ?

- (v) Whether the of the respondent no - 2 Deputy Collector Land Reforms, Uda - kishunganj should not be punished for his illegal tact of practice & procedure ?
- 4 That the fact of this case is that the land in question appertaining to case khata no-354 , plot no – 200, Area -92 decimals of land was in the name of Sokhi Tatma & sumrit Tatma both are s/o Late Lalu Tatma sold the land in question in the hand of Banarasi Ram.

Banarasi Ram also sold the land in question to Upendra Das on 31.01.1956.

Upendra Das divided the plot no. - 200 Area -92 decimals in two parts, one part of 77 decimals of lands of R.S plot no- 1109 & second part of 15 decimal of land of R.S plot no-3425/1109.

In Revisional survey old khata no -354 come into existence as R.S khata no.-1008 & plot no-200 come into existence as plot no-1109 & plot no-3425/1109.

The respondent no- 2<sup>nd</sup> set in collusion with the Survey Officer Madhepura opened a new plot 3425/1109 in the name of Sokhi Tatma & Sumrit Tatma. The plot no-201 is the adjacent plot of plot no.- 200, plot no.- 201 is the plot of respondent no.- 2<sup>nd</sup> set.

The respondent no - 2<sup>nd</sup> set in collusion with the Survey officer opened a new khata no.-84 plot no-1109/200 total no.-77 decimals of land which is wrong.

Upendra Das sold the total land on – 26.08.1968 by three registered sale deed no. - 1823 / 1968 , 1822 / 1968 & 1824/1968 in the hand of Suryug Sah & others .

Father of the petitioner - 1 and Father of the petitioner – 2 have filed a title suit no - 16/81 before the learned Munsif Madhepura against Laxmi Das & others . The learned Munsif Madhepura after notice to the defendants & after hearing both the parties & perusing the records khatiyan maps & other related documents & also hearing the witnesses of both the sides passed the decree in favour of the plaintiffs Suryug Sah & others on 31 .01.1984

A true photocopy of the decree dated 31.01.1984 is annexed here with marked as Annexure -1 of the petition.

- 5 That the father of the petitioners Suryug Sah & others filed a execution case no.-6/1984 before the Munsif & execution was passed in favour of the father of the petitioners on 03.10.1985 .

A true photocopy of the execution case no - 6/1984 is annexed here with marked as Annexure -2 of the petition.

6. The defendants Ram Chandra Das & others filed a misc. case no - 5 / 87 against the order of decree dated 31.01.1984 passed in title suit no. - 16 / 81 by learned Munsif Madhepura. The learned

Munsif Madhepura after hearing both the parties rejected the misc. case no. 5/87 on 30.04.1988.

A true photocopy of the misc case no - 5/87 order dated 30.4.1988 annexed here with marked as Annexure - 3 of the petition.

- 7 That since the registry by Upendra Das in the hand of the father of the petitioners, they all are coming in peaceful possession over the land which was also decreed.
8. That after registry & decree , the father of the petitioners filed a petition before the C.O for mutation and for which a mutation case no. -145/87-88 was filed.After due procedure the land was mutated and jamabandi no.-1660 was opened in the name of the father of the petitioners and rent is being deposited since that period .
9. That on 06.10.1977 when the new khatian was prepared and when the petitioner & others knew that plot no-3425/1109 area 15 decimals of land which is the part land of plot no.-1109 is being opened in the name of Laxmi Das & others.The father of the petitioners approached to the father respondent no.-7 and requested them to make correction in the records of right which was done due to mistake .The father of the petitioners have no knowledge u/s 106 of the B.T act which was filed for the correction of the records of rights.
10. That the 15 decimals of land which is the land of dispute is being mutated in the camp court by the respondent - 3 in collusion with the respondents – 4 ,5 and 6 which was obtained by auction court sale

on 3.10.1985 on account of expenses incurred in the title suit no.- 16/81 .

11. That Ram Chandra Das took the 15 decimals of land by gift from the hand of Sumrit Tatma which is already sold by Sumrit Tatma & his brother Sokhi Tatma to Banarasi Das.
12. That the petitioners have filed a mutation appeal before the respondent -2 Deputy Collector Land Reforms Uda - Kishunganj & still today the case is pending.

It is therefore , prayed that your lordships may graciously be pleased to admit the writ petition,call for the records and issue notice to the respondents and after hearing the parties, grant the reliefs sought in paragraph no.- 1 of the petition.

And/Or

Pass such other / orders as your Lordship may dim fit & proper.

And for this the petitioner shall ever pray.
