The Hon'ble Justice Rekha M. Doshit, the Chief Justice of the Hon'ble High Court of judicature at Patna and her Companion Justices of the said Hon'ble Court.

The humble petition on behalf of the petitioner named above:

Most Respectfully Sheweth:-

1 That by this writ petition, petitioner Seeks indulgence of this Hon'ble High Court for the following relief :-

- I. For Commanding the respondent to set aside the selection list of Anganwari Sevika for promotion on the post of Anganwari Supervisor finalized by the respondent no. 5 the collector Head of the selection committee whereby and whereunder the application of the petitioner has been negative on account of her appointment in underage.
- II. For further commanding the respondents to prepare a fresh list of Anganwari Sevika for promotion on the post of Anganwari Supervisor according the merit as well as the condition of I.C.D.S.

III. For further commanding the respondent to select the petitioner on the post of Anganwari Supervisor canceling the order dated 11.07.2011 passed by the District Programme Officer Madhepura in the light of the letter No. 731 dated 24.02.2012 by which the appointment of the candidates have been made under age is valid according the conditions of the I.C.D.S.

IV. To grant any other relief or reliefs as to which the petitioner may be entitled into its facts and circumstances of the case.

2. That the petitioner is a Citizen of India.
3. That the following substantial question of law are involved in the present writ.

- I. Whether not to promote the petitioner on the post of Anganwari Supervisor when she deserves for the same and fulfils all the requirements is justified?

II. Whether the act of the respondent is not arbitrary and malafide when the petitioner fulfilled all the requirements inspite of that she has not been promoted is justified?

III. Whether the respondents should not be punished for their illegal and arbitrary manner?

4. That the fact of this case is that the petitioner has been working on the post of Anganbari Sevika at Kendra No. 79 Anganbari Centre Bandha Panchayat Nadhi P.S. Murliganj District Madhepura since 1984 after selection vide letter No. 62 dated 06.11.1984.

A true photo copy of the appointment letter no. 62 dated 06.11.1984 is annexed herewith and marked as Annexure-1 to this petition.

5. That the petitioner has been working very satisfactorily and the work of the petitioner was

appreciated and awarded time to time. There is no complaint against the petitioner in performing the duties of Sevika.

6. That pursuant to the Advertisement No. 01 I.C.D.S. 1068/01/875/Sak dated 14.06.2010, the petitioner applied for the post of Anganbari Supervisor by selection from the Anganbari Sevika .The petitioner according to the Advertisement submitted the applications on line and also submitted all the papers to the respondent of the concerned block on 13th July 2010.

A true photo copy of the application dated 13.07.2010 is annexed herewith and marked as Annexure-2 to this application.

7. That a formal list of the candidate appearing candidates have been made and her name was appearing according to the merits.
8. That the respondents set over the matter for indefinite period and no information with regard to the promotion of the Anganbari Sevika on the post of Supervisor was given.
9. That the petitioner made several efforts to get the information with regard to promotion of Anganbari Sevika.
10. That the final merit list of Anganbari Sevika for promotion was finalized by the selection committee on 01.07.2011 and the petitioner obtained this merit list from the office in the month of April 2012 and her name doesn't find place in the merit list.

A true photo copy of the merit list is annexed herewith and marked as Annexure-3 to this petition.

11. That the respondent no. 6 District Programme officer by his letter dated 11.07.2011 asked the petitioner to submit her evidence till 15.07.2011 with regard to appointment on the post of Anganwari Sevika in underage.

A true photo copy of the letter dated 11.07.2011 is annexed herewith and marked as Annexure-4 Series to this petition.

12. That the petitioner has passed the Matriculation Examination in the year of 1983 with 49.33% marks, Intermediate in 1986 with 43% marks B.A.Hons in the year of 1992 with 56% marks and in M.A. in the year of 1994 with 60.5% marks.
13. That the Scheme I.C.D.S. under the Social welfare Department have taken special care for selection of Anganbari Sevika at the age group of 15-44 years of old

candidate. This is the condition of the selection of the Anganbari Sevika.

A true photo copy of the I.C.D.S. is annexed herewith and marked as Annexure-5 to this petition.

14. That the secretary, Social welfare Department Bihar Patna vide letter No. 731 dated 24.02.2012 has clearly directed the collectors of Bihar to promote the Anganbari Sevika on the post of Supervisor who have been appointed in underage.

A true Photo copy of the letter no. 731 dated 24.02.2012 is annexed herewith and marked as Annexure-6 to this petition.

15. That the Anganbari Sevika of different Blocks of Purnea District who have been appointed in underage, have been promoted on the post of Supervisor.
16. That the act of the respondents is illegal, arbitrary, malafide and unconstitutional.
17. That the petitioner has no other alternative or efficacious remedy except to move before this Hon'ble High Court.
18. That the petitioner has not moved earlier in this matter before this Hon'ble High Court.

It is therefore prayed that your Lordships may graciously be pleased to admit this application, issue Rule NISI, calling upon the respondents to show cause as to why the relief sought for in paragraph no. 1 of this writ application may be not granted and further return of the rule and

respondents showing no sufficient
cause rule NISI be made absolute.

And/Or

Pass such other order or orders as
your Lordships may deem fit and
proper.

And for this the petitioner shall ever pray.

2. A copy of the scheme is enclosed. All the details of the scheme including financial assistance have been shown therein.

3. A perusal of the scheme will show that this has to be implemented on the pattern of the existing ICDS projects in your State. The scheme gives the general model for the rural, tribal and urban project area. The demographic features of each project and the organisational details in different State are likely to vary an account of the actual features of the selected project areas as well as difference in the administrative set ups in different States. The State Government may therefore adapt the general model to suit the local circumstances. However, in case of major deviation from the general model, appropriate proposals with reasons may be sent to this Department for consideration.

4. (i) One child development project Officer (CDPO) is to be in overall charge of the scheme in each project area.

(ii) The Child Development Project Officer should be a graduate in Child Development or Social Work or home science or nutrition or any allied field.

(iii) Our experience from the existing projects has shown that if the Child Development Project Officer has any of the above mentioned background, he/she would be able to implement the scheme more efficiently. It would, therefore, be desirable that a good officer, having the above indicated qualifications may be selected from any one of the State cadres.

(iv) If no suitable officer is available from any existing cadre of the State urgent steps should be taken to select the officer with the above mentioned qualification.

(v) The officer will have to be borne on some appropriate State cadre and may preferably be a lady.

(vi) His/Her pay scale shall be the same as that of the Block Development Officer in the State.

(vii) The same name and designation of the officer selected for each project may be communicated to this Department so that we can organise the training of the CDPOs.

5. As mentioned in the scheme, a rural project will have 5 mukhyasevikas (Supervisors), an urban project will have 4 mukhyasevikas & a tribal project will have 3 mukhyasevikas.

(ii) These mukhyasevikas will supervise and guide the work of the anganwadi worker. She will have to look after a certain no. of anganwadis.

(iii) The pay scale of the mukhyasevikas would be the same as that of the mukhyasevikas in the State.

(iv) As in the case of the Child Development Project Officer it would be preferable if mukhyasevikas also have the background either of child development or home science or social work or nutrition or of an allied field.

(v) Our experience from the existing projects has been that the younger mukhyasevikas have done better. It would therefore, be better to select young and energetic persons as mukhyasevikas.

(vi) If the State Government so desire they may resort to direct recruitment of mukhyasevikas. Otherwise suitable and energetic existing mukhyasevikas or senior Gramsevikas or other similar functionaries may be considered for appointment as mukhyasevikas.

(vii) As soon as the State has finalised the selection of mukhyasevikas and intimation may be sent to this Deptt. so that instructions can be issued regarding the training course for them.

Anganwadi worker who would be the village level worker in charge of the delivery of various services under the scheme. She would actually be the focal point for the Panchayat in each village.

i) The anganwadi worker would be an honorary worker selected from the village community itself.
ii) She will receive an honorarium of Rs.175/-per month if she is a matriculate & Rs.125/-per month if she is non-matriculate.

iii) It would be preferable if matriculate anganwadi workers are selected. Otherwise the anganwadi worker should at least have passed standard VIII. However in special circumstances where no standard VIII pass anganwadi worker is available anganwadi workers with a pass at least in standard VI may be appointed if they are found suitable.

iv) The anganwadi worker should be lady in the age group 15-44 years from the local village.

v) It is essential that the anganwadi worker should be from the same village where she has to work because such a person would be more acceptable in the local community.

vi) Special care should be taken in her selection so that the children of Sch. Castes and Sch. Tribes and other weaker sections of the society are ensured free access to the anganwadi.

vii) If in any village, any balwadi or anganwadi is already in existence, the same may be utilised as the anganwadi centre under our scheme, but it has to be ensured that the anganwadi worker fulfils the conditions are laid down above.

viii) It is suggested that the anganwadi workers from the project may be selected by a committee consisting of the District Social Welfare Officer, the Additional District Magistrate, the BDO of the block, the Child Development Project Officer (if he/she is in position) the present of the Taluka Panchayat Block Advisory Committee and any other prominent citizen of the block. But this, however, is left to the State Govt. to decide.

ix) Selection of the anganwadi workers has to be made as early as possible so that first training course for them may be commenced on 1 April, 1978. As soon as the anganwadi workers are selected, an intimation may be sent to this Department so that suitable instructions may be issued regarding their training.

7. Each anganwadi worker should be assisted by a helper in the cooking of food clearing of anganwadi, clearing of utensils etc. He/She will be paid a sum of Rs.50/-per month. As he/she has to work with the anganwadi worker it would be suitable if she is employed from the same village.

8. Coordination :-The success of the scheme mainly depends on the effectiveness of the coordination at various levels because the scheme envisages and integrated delivery of a municipality of services which are handled by different departments at different levels. It is presumed that the Coordination Committee at State level would have already been not set up because of the existing ICDS project in your State. District, Block and Village level committees may be sent up in the new ICDS project areas. General guidelines for the setting up of coordination committees have been given in Appendix-D to the scheme enclosed herewith. The constitution of the committees at different level by the State Government may please be communicated to this Department.

9. Participation by Social Welfare Advisory Boards Voluntary Organisations etc. :

The emphasis under the ICDS scheme is that the ICDS projects should be run by the voluntary organisation. The implementation of the ICDS projects can also be give to the Social Welfare Advisory Boards, Local Bodies, Panchayat etc. These organisations can be given assistance for running the anganwadi. The Central Social Welfare Board and the State Social Welfare Advisory Boards should, therefore, be involved necessary and in promotion and development of the existing voluntary organisations.

10. As mentioned in the scheme, the health infrastructures in each project area is to be strengthened by providing additional staff from the ICDS funds. For this purpose, the following additional staff is to be appointed in each PHC :-

- (1) 1 Doctor preferably in the field of paediatrics.
- (2) 2 LHV/PHNS in each rural/tribal project.
- (3) Additional ANMs in each rural/tribal project so that there is one ANM for the population of 5000. For this, it is necessary that the State Government has provided the necessary number of ANMs in the programme of Integration of Family Planning and under M.N.P. only the number of ANMs over and above this is to be provided from the ICDS funds.
- (4) 4 ANMs in each urban project.

As mentioned above also, the State Government will have to provide the health infrastructure including staff, medicines and other facilities in the ICDS blocks on the basis of the pattern approved under the Minimum Needs Programme in the State Sector. The State Govt. should therefore, take pattern approved under the MNP and under the ICDS Projects. A letter from the Ministry of Health and Family Welfare & letter no. 1-4/78-CD dated 3.3.78 from this Department has already been issued for filling up these posts. As soon as the health infrastructure in the ICDS project areas comes up to the pattern laid down in the ICDS scheme, these health personnel will have to be oriented in the ICDS scheme. It may, however, be clarified that the additional health personnel will have to be oriented in the ICDS scheme. It may, however, be clarified that the additional health personnel appointed from the ICDS funds would not be separate from the other staff at the PHC. The whole of the staff at the PHC has to be integrated as one and the whole ICDS project area under the PHC. will have to be divided amongst all the staff at the PHC. Overall administrative Control over the health staff would be that of health Deptt.

11. The ICDS scheme should be integrated with other allied schemes of the Ministries/Departments of the Government of India as well as the State Governments in order to produce a deeper impact in the project areas. For instance, the schemes of drinking water supply, applied nutrition programme, mobile food and extension units etc. should be started on a priority basis in the ICDS project areas.

12. As mentioned in the ICDS scheme also, the cost of the nutrition component in the ICDS scheme has to be met from the State Sector under the Minimum Needs Programme. You may recall that at the time of discussions of your State Plan, it was ensured that adequate provision was made for this purpose in the State Plan outlay for 1973-79. The approved pattern for nutrition in the ICDS blocks is 25 paise per day per beneficiary and 60 paise per day per beneficiary in respect of severely malnourished will merge in the anganwadi meaning thereby that no SNP Centre would run independently at the anganwadi.

13. Regarding the training of various functionaries, separate communications will follow :

14. The ICDS scheme is 100% Centrally Sponsored Scheme except the nutrition component, the expenditure of which has to be met by the State Government under the SNP. The State Government may therefore, make immediate arrangements to complete the budgetary formalities for providing funds at the State level and releasing these funds to the concerned State Officers so that no delay is experienced in the implementation of project on account of difficulties in the financial sanctions.

15. It is requested that the appointments and postings of all the staff, both on social welfare side health side may be made as quickly as possible so that their training may start without any avoidable delay.
