For direction in nature of mandamus commanding the respondents to immediately grant the tender Notice No.1/2012-13 in favour of petitioner for settlement of Sakrat which has been purchased the short tender notice through Sakrat settlement under the signature of Executive Officer ,Nagar Panchayat,Murlijanj, Distt- Madhepura which was published in Hindustan Daily news paper on 27.3.2013. for settlement of Rajesav Gudri Hat Murlijanj, toll tax of private bus stand, Murlijanj

by which date of notice, but which was held on 30.3.13
whereas the rules prescribed for settlement of the bid
in 3 dates, whereas on that day there was administrative
gazetted Holidays of the N.I. Act. that was the opening
day at about 12 O' Clock for that the several bidders
including the petitioner they were not participated
in the aforesaid Bid.

- For further directed the respondent to immediately
fix the next date for settlement of the bid through
short tender notice so that revenue of the state govt.
may be collected.

MOST RESPECTFULLY SHEWETH:

1. That the petitioner of this case file this
writ application for grant of following reliefs:-

- (1) For issuance of writ/writs, order/orders
direction/directions in nature of mandamus
compelling the respondents to immediately
grant the petitioner Notice No.01/2012-13
in favour of the petitioner for settlement
of Sahra which has been ^{published} purchased the

short tender notice through seized settlement under the signature of Executive Officer, Nagar Panchayat, Murliganj, District-Madhepura whereby and whereunder the short tender notice was published in Hindustan Daily Newspaper dated 27.3.2013 for settlement of Rajeev Gudri Hat Murliganj, the toll tax of private Bus stand, Murliganj and for transport of goods of vehicle under Nagar Panchayat Murliganj by which the date of notice, but which was held on 30.3. 2013 whereas the rules prescribed for settlement of the bid in 3 dates.

(II) For further directed the respondents to again invited the short tender Notice for settlement of the seized of Nagar Panchayat Murliganj because in earlier short tender notice no.1/12- 2013 which was published in the Hindustan

daily Newspaper dated 27.3.2013 whereas on that day there was administrative Gasetted Holidays of the N.I,Act but the short Tender Notice was invited and the date of settlement of the bid which was held on 30.3.2013 that was the opening day at about 12 O' Clock for that the several bidders including the petitioner they were not participated in the aforesaid Bid.

(11) For further directed the respondent to immediately fixed the next date for settlement of the bid through short tender notice so that the Revenue of the state government may be collected .

(12) For further any other a called/reliefs order/orders,direction/directions may deem fit and proper in the facts and circumstances of this case.

3. That the petitioner is citizen of India and the ordinary resident of District Madhepura, within the territorial jurisdiction of this Court.

3. That the moot questions of law besides other arises consideration of this Hon'ble court may may deem fit and proper in the facts and circumstances of this case.

(1) whether the action of the respondents is not illegal, mala fide and may indiscriminately so that the Executive Officer, Nagar Panchayat Murliganj who has invited the short tender notice No.01/2012-13 which was published in daily Hindustan Newspaper for settlement of Rajawa Gudri Hat Murliganj, toll tax, of the vehicle under Bus stand Murliganj

and the transporting of goods of vehicle
 by which the short tender notice was invited
 by the respondent no. 5 ,but on 27.3.2013 ,
 28.3.2013,29.3.2013 there was gazetted Holidays
 therefore the action of the respondent which
 is not illegal ?

(ii) Whether the action of the respondent is
 not illegal while the date of short tender
 notice was invited by the respondent no. 5
 purposely so that no other bidders may not
 participated ⁱⁿ /the aforesaid bid due to which
 the government had suffer a serious loss of the
 GOVT. Revenue?

(iii) whether the other bidders they were ready
 to accepted the bid of all three settlements on
 high rate ,so far the private respondents
 no.6,7 and 8 they were the Manager of office

of Executive Officer, Nagar Panchayat Murliganj
and intentionally published the short tender
notice on 27.3.2013 while there was the
National Holidays that very day due to which
the several bidders they were not participated
the aforesaid tender notice moreover the other
bidders namely Hirodh Singh had been went to
the office of the Executive Magistrate Nagar
Panchayat Murliganj for participated the
Open bid but the muscle man they were threaten
the other bidders so that the other persons
were not participated the bid accordingly
the matter was inform by several bidders
before the respondent authorities including
Executive Officer, Nagar Panchayat, Murliganj

but no action has been taken by the respondents authority as such the action of the respondent is not illegal.

- (iv) whether the matter which was not consider by the respondent no.5 thereafter the petitioner alongwith several other bidders they were file joint petition before the district Magistrate-cum-Collector ,Madhepura on 10.4.13 and 6.4.2013 so far the petitioner was filed by the petitioner alongwith other persons by way of the joint petition on 30.3.2013 at about 2.30 P.M. before the Executive Officer, Nagar Panchayat ,Muzilganj district-Madhepura but no action has been taken in this regard because the private respondents no.6,7 and 8 they were

managed the office of Executive Magistrate,
Nagar Panchayat, Muxliganj ?

(v) Whether the respondents authorities who
have not exercised of their powers regarding
the Sakat settlement of the bid which was
published under the office of Executive Officer,
Nagar Panchayat Muxliganj, District-Madhepura
so far the lowest bidder they are the private
respondent nos.6,7 and 8 who have manage the
office Nagar Panchayat ,Muxliganj District-
Madhepura as due to above said reason the short
tender notice was published in that very date ?

(vi) whether the respondents no. 5 without
obtaining the administrative approval from the
Divisional Commissioner ,Kosi Division ,Saharsa

the short tender notice was published whereas the rule has been prescribed that the administrative approval from higher officer is required for settlement of Sakrat for collection of toll tax under Nagar Panchayat, whereas the respondent no. 5 without obtaining the Administrative approval invited the short tender notice as such the action of the respondent is not illegal.

- (vii) Whether the action of the respondents is not malafide and indiscriminately so that from perusal of invited short tender notice No. 01/2012-13 it appears that in column no. 1 for settlement of Rajaswa Gudri Hat, Muzliganj the security amount is Rs. 6,55,100/- whereas the column no. 4 of the short tender

notice the amount of earnest money Rs.1,31,100/-
 whereas the petitioner is ready to receive the
 afore said settlement of the bid Rs.9,00,000/-
 and from perusal of the column no.3 for
 collection of toll tax of the private vehicle
 the security amount which is required Rs.
 Rs.5,01,500/- and the earnest money (20%)
 1,00,300/- whereas the petitioner is ready to
 accepted the collection of toll tax for settle-
 ment Rs.10,0000/- and so far for entrance of
 the goods vehicle (Mail Vahana) the security
 amount Rs.1,25,000/- and the earnest money is
 required (20%) Rs.25,000/- whereas the petitioner
 being the bidder ready to accepted on security
 amount Rs.3,00,000/- inspite of the petitioner
 being the highest bidder the aforesaid work
 for Sakat settlement of toll tax under Nagar

Nagar Panchayat, Murliiganj which is not allow the petitioner and other several bidders for participated in the bid due to which the govt. has suffer a serious loss of revenue.

(viii) Whether the action of the respondents is not illegal, arbitrary, mala fide, unjustified so that the date of bid which was published in daily Hindustan Paper i.e. 27.3.2013 while on that very day there is National Holidays and till 29.3.2013 the National Holidays was continue and on the next opening day i.e. 30.3.2013 the settlement of bid which was held under the compass of Nagar Panchayat Murliiganj while the office was fully manager by the private respondent no.6,7 and 8 ?

(ix) whether can from perusal of short tender

notice dated 27.3.2013 it appears that the column no.5 the date of open bid which was filed on 3 dates on i.e. 30.3.2013 first date, then 1.4.2013 i.e. is second date and 2.4.2013 i.e. third date but all three tenders which was held on only one date i.e. on 30.3.2013 therefore the respondent authorities who has not consider the rule prescribed as per the term and condition of the short tender notice No.01/2012-13 as such the action of the respondent is not illegal, mala fide and indiscriminatory?

4. That the short fact of the case inshort is that tender notice was invited and published on 27.3.2013 in Hindustan Daily Newspaper vide Tender Notice No.01/2012-13 which was invited under the

signature of Executive Officer, Nagar Panchayat ,
 Muzilganj district-Madhapura ,for seikat settlement
 for collection of toll tax of private vehicle bus and
 Auto Rickshaw ,and Magic vehicle as well as the
 others private vehicles which was published the short
 tender notice by the office of Executive Magistrate
 Nagar Panchayat ,Muzilganj District-Madhapura with
 regard to authority to levy toll tax for using bus
 stand and hauling station of Muzilganj Bus stand,
 as well as also for settlement of collection of goods
 vehicle.

A photocopy/typed copy of the
 short tender notice no.01/2012-13
 which was published in Hindustan
 daily newspaper is annexed and
 marked as Enclosure-1 to this writ
 petition.

25. That the aforesaid tender notice of the respondent authorities that toll tax should be consistent with the toll tax as being realised from the owners of the private Bus owners as well as rickshaw and other private vehicle owners for Haunting station and or at bus stop and haunting station.

26. That under the rules of ¹⁹¹ 1992 of the Bihar Motor vehicles rules 1992 as well as the Notification dated 26.7.1998 has already notified some places of Koshi Division as bus stands ,Maxi taxi as well the bus stand and as Bus stops vide Schedule 1 and 2 that with regard to the collection of the toll tax the respondent authorities drawing the attention to the aforesaid facts and request was made by the necessary action by the respondent authorities that the toll tax should be consistent with toll tax as being realised by the office of Executive Offices,

Nagar Panchayat Murliganj district-Madhepura whereas on the basis of the guideline as per the Bihar Nagar Palika Adhiniyam 2007 the settlement of the bid of saikat which was invited by the respondent authorities i.e. Executive Officer ,Nagar Panchayat Murliganj but the aforesaid tender notice which was published in daily Newspaper Hindustan published on 27.3.2013 while on that very date there was National Holidays ,therefore the private respondent who have manage the office of Nagar Panchayat , Murliganj and from back door entry they were obtain the work order. So far the other several bidders, they were interested of the aforesaid saikat settlement but they were not public participated.

6. That from perusal of the short tender notice dated 27.3.2013 in Column no. 1 ,2 and 3

it appears that the name of the sairat settlement and from perusal of column no.5 it appears that the date was fixed for the first settlement on 30.3.2013, and the second settlement of the bid which was fixed on 1.4.2013 on the next date and the third date on 2.4.2013 for settlement of the sairat but all the tenders which was allotted and granted in favour of the private respondents on 30.3.2013 which was published in the daily Hindustan newspaper dated 1.4.2013 meaning thereby the private respondents who have manage the office of Nagar Panchayat , Nurliganj District-Medhapura and without following the prescribed of the rules the settlement of the sairat which was granted in favour of the private respondents.

A photocopy of the daily Hindustan
paper cutting dated 1.4.2013 is
annexed herewith and marked as
Annexure-2 to this writ petition;

7. That the petitioner being the interested
bidders as well as the others bidders they were
interested of the aforesaid saikat settlement works
they were filed by way of the representation on
30.3.2013 before the Executive Officer, Nagar
Panchayat, Muzliganj, District-Madhapura at about 3.30PM
while the date of bid was held so far the short
tender notice dated 27.3.2013 it appears that there
was National Gazette Holidays whereas some of the
bidders have made claim that in very short time
within three days in short tender notice was published
and invited the bidders but they are not allowed in

participated in the bid because the muslims they
were manage the entire office of the Executive
Magistrate.

6. That while the representation of the peti-
tioner dated 30.3.2013 which was not consider by
the Executive Officer, Nagar Panchayat Muzliganj
(Respondent no.5) thereafter the petitioner alongwith
other bidders they were filed a joint application
on 1.4.2013 before the Hon'ble Chief Minister,
State of Bihar, Patna through the Fax,

A photocopy of the representation dated 1.4.2013 filed by the petitioner alongwith other bidders is annexed herewith and marked as Annexure-4 to this writ petition.

9. That while the responding authority (Executive Officer, Nagar Panchayat Murliganj, Distt-Madhepura) who has not consider the representation on 30.3.2013 filed by the petitioner alongwith the several interested bidders thereafter the petitioner alongwith the other bidders when dissatisfied with the action of Executive Officer and accordingly the petitioner alongwith other bidders moved and filed by way of the representation on 1.4.2013 before the District Magistrate-cum-Collector, Madhepura and has been

made request for again re-open the bid of the subd
aforesaid Sairat settlement of under Nagar Panchayat
Mulliganj District-Madhepura.

A photocopy of the representation
dated ^{1.4.2013} ~~6.4.2013~~ filed by the
petitioner before the District
Magistrate, Madhepura is annexed
and marked as Annexure-5 to this
petition.

10. That again the petitioner has filed the
representation for consider the earlier application
filed by the petitioner but no action was taken
in this regard accordingly the petitioner alongwith
2 other bidders have filed by the way of joint repre-
sentation on 6.4.2013 before the District Magistrate,
Madhepura and has been made prayer for cancelled

the short tender notice no.01/2012-13 in column no.4 the draft of earnest (security amount) money which was required as per the column no.1 of the term and condition therefore several bidder they were make request to the respondents authorities for extended the date of bid but which was not consider and without open bid only the work was completed by the respondents authorities concern and the back door entry the private respondent nos.6,7 and 8 they were allotted the aforesaid work without following the prescribed rate of Bihar Nagar Palika Niyam Niyamodhi, 2007.

12. That all the private respondents they are close relative of the chairman of the Nagar Panchayat Muziganj District-Madhepura and for the above said reason the short tender notice was published on

27.3.2013 while on that very day there was National
Gazetted Holidays.

13. That there is no efficacious and alternative
remedy to the petitioner save and except to move
before this Hon'ble Court for redressal of his
grievance.

11. That the petitioner has earlier not moved
for grant of any writ petition previously before
this Hon'ble Court in the present matter.

It is, therefore, prayed that your
Lordships may graciously be please
to admit this writ petition, issue
rule nisi, calling upon the respondents
as to why the reliefs as prayed in
para no.1 of this writ petition may
not be allowed in favour of the

petitioners;

And

It is further prayed that during the pendency of the writ petition may kindly stay short tender notice No. 1/2012-13 dated 27.3.2013 during the pendency of the aforesaid writ petition.

pass such other order or orders as your Lordships may deem fit and proper.
