SYNOPSIS

Prayer:- For quashing the Memo No. -221 dated 16.6.2013 issued by Block Education Officer, Chausa cum- Member-secretary Block Employment Unit Chausa Block in district- Madhepura, terminating the service of petitioner as Prakhand Teacher on the ground that Graduation (Sahityalankar) degree of Hindi Vidyapeeth Deoghar is not recognized for employment of Prakhand Teacher. the order contained in Memo No. 221 dated 16.6.2013 issued by B.D.O. Chausa-cum- Member Secretary , Block Teacher employment Unit Chausa, district- Madhepura, be quashed. petitioner be reinstated on the same post with all consequential benefits and be paid his salary from the date of joining also as well as other relief/s permissible under the facts and circumstances of the case.

Facts of the Case

10-11-91 The Govt. of India as well as Govt. of Bihar granted permanent recognition to Praveshika/Sahitya Bhushan/

Sahityalankar degrees equivalent to Matriculation/ Intermediate and B.A. degrees as granted by Hindi Vidya peeth Deoghar by different Notification issued in this regard. So far Govt. of India is concerned, its recognition is of 18th February 1970 issued by Education and Youth Welfare Ministry ,New Delhi and of Bihar Govt. vide order No.8/R & 303/84.

27-8-08 H. R.D. Department , Govt. of Bihar has issued a letter vide Memo No. 1346 by principal Secretary of the dept. mentioning therein that different certificates issued by different Vidyapeeth as well as other such education council/College, is not recognized for employment of general teacher of High & Higher Secondary schools. Including Sahityalankar -equivalent to B.A. degree granted by Hindi Vidyapeeth Deoghar.

14-5-12 As per requirement of being Prakhand Teacher or other teachers of a school , it was made incumbent to pass Bihar Elementary Teacher Eligibility Test ,2011 conducted by S.C.E.R.T ,Bihar Patna and B.S.E.B. Patna Jointly for which minimum qualification, has been also fixed for the teachers to be appointed for class 6 to 8 i.e. B.A./B.Sc./ B.Com./ Alim/Shastri or its equivalent + 2 years diploma/B.Ed./4 years Elementary Education/Graduate/Two years Diploma

III.

(Special Teacher) /One year Regular B.Ed (Special Education) two years distant education Graduate course etc. with minimum 50% marks and equivalent degrees, accordingly the petitioner appeared in T.E.T and was declared qualified and a certificate has granted to him by B.S.E.B. Patna.

- 15.6.13 Petitioner applied for Prakhand teacher in Chausa Block
10.7.13 District- Madhepura and was selected for the same and issued appointment letter by the Block Teacher Employment Unit Chausa, Madhepura as un trained teacher Memo No.167 which was received by him on 6.7.13 and he joined in . Upgraded Middle School Heeratola Paina as Hindi Teacher ,which was duly accepted by the concerned Headmaster of the school.
- 16.9.13 From the date of joining petitioner continuously worked till 16.9.13 in the said school but all on a sudden on 16.9.13 he received memo No.221 issued by B.D.O.-cum Member Secretary of Block Teachers Employment Unit Chausa, Madhepura cancelling his appointment and declaring the seat as vacant on the ground that the petitioner has obtained graduate degree from Hindi Vidyapeeth Deoghar, which is not recognized for employment of Block teacher.

.Hence this writ petition.

Most Respectfully Sheweth:-

1. That, this application is being filed for issuance of an appropriate writ(s)/order(s)/direction and thereby to issue a writ in the nature of 'Mandamus' quashing the Memo No. -221 dated 16.6.2013 issued by Block Education Officer, Chausa cum- Member-secretary Block Employment Unit Chausa Block in district- Madhepura, terminating the service of petitioner as Prakhand Teacher on the ground that Graduation (Sahityalankar) degree of Hindi Vidyapeeth Deoghar is not recognized for employment of Prakhand Teacher and thereby to direct the authorities to reinstate the petitioner on the said post with all consequential benefits.

3.

2. That the petitioner prays for the following relief(s) by way of this writ application:-

- (i) The order contained in Memo No. 221 dated 16.6.2013 issued by B.D.O. Chausa-cum- Member Secretary , Block Teacher employment Unit Chausa, district- Madhepura, be quashed.
- (ii) The petitioner be reinstated on the same post with all consequential benefits.
- (iii) The petitioner be paid his salary from the date of joining also.
- (iv) The Petitioner be granted Cost of legal proceeding throughout.
- (v) Petitioner be also granted any other relief/reliefs permissible under the facts and circumstances of the case.

3. That, following questions of law inter alia arises for Your Lordships consideration in the instant writ application:-

- I. Whether the impugned order dated 16/6/2013 issued by respondent No. 5 is valid in the eye of law ?
- II. Whether recognition granted by the State of Bihar vide Govt. Notification No. 8/R. and 384/84-541 dated 11th January 1991 of Sahityalankar granted by Hindi Vidyapeeth Deoghar as well as Govt. of India dated 18-2-1970 by department of Education & Youth welfare Ministry recognizing the same equivalent to B.A. degree is valid or not ? in view of the order

of Bihar Govt. Human Resources Development Department dated 27.8.2008 ?

- III. Whether the examination conducted by S.C.E.R.T Bihar Patna for Bihar Elementary Teacher Eligibility Test -2011 recognizing B.A./B.Sc./ B.Com or its equivalent examination ~~is~~ has any relevance for appointment of Prakhhand teacher ?
 - IV. Whether termination of petitioner appointed as Prakhhand teacher is invalid on the basis of order dated 27.8.08 issued by the Principal secretary declaring degree of Sahityalankar by Hindi Vidyapeeth Deoghar nd equivalent to B.A. degree has any legal force ?
 - V. Whether termination of the petitioner's service in complete violation of principle of natural justice and without hearing him is violative of Article 311(2) of the Constitution of India ?
4. That the petitioner is a citizen of India and cause of action arose within the territorial jurisdiction of this Hon'ble Court.
 5. That as per requirement of being Prakhhand Teacher or other teachers of a school , it was made incumbent to pass Bihar Elementary Teacher Eligibility Test ,2011 conducted by S.C.E.R.T ,Bihar Patna and Bihar School Examination Board, Patna Jointly for appointment of teachers up to class 1 to 5 and Class 6 to 8 as per the provisions of compulsory and free child education Rights Act, 2009 vide Section 23(2) of the Act and minimum qualification has

been also fixed for it and for the teachers to be appointed for class 6 to 8 minimum qualification is graduation i.e. B.A./B.Sc./ B.Com./ Alim/Shastri or its equivalent + 2 years diploma/B.Ed./4 years Elementary Education/Graduate/Two years Diploma (Special Teacher) /One year Regular B.Ed (Special Education) two years distant education Graduate course etc. with minimum 50% marks and equivalent degrees having minimum 18 years of age on 17.7.2011 and maximum age deferred from general category to S.T. as well as for lady candidates in between 37 to 42 years with definite prospectus and syllabus and accordingly the petitioner appeared in the said examination and was declared qualified being a extremely backward class category candidate and a necessary certificate has ^{been} granted to him by Bihar School Examination Board Patna on 14.5.2012.

A copy of Result Card of BETET issued by B.S.E.B. Patna dated 14.5.2012 is annexed herewith and marked as Annexure:-1 to this petition.

6. That thereafter petitioner applied for Prakhand teacher in Chausa Block ,District- Madhepura and he was selected for the same and issued appointment letter by the Block Teacher Employment Unit

Chausa, Madhepura as un trained teacher and was issued necessary appointment letter vide Memo No.167 dated 15.6.2013, which was dispatched at his address on 4.7.13, which by speed post/registered post and received by him on 6.7.13 and accordingly he joined in the allotted school i.e. Upgraded Middle School Heeratola Paina as Hindi Teacher ,which was duly accepted by the concerned Headmaster of the school.

A copy of appointment letter contained in memo no.167 dated 15.6.13 and joining letter dated 10.7.13 and its acceptance by H.M. of the school are annexed herewith and marked as Annexure:-2 & 3 respectively.

7. That from 10.7.2013 he continuously worked till 16.9.2013 in the said school but all on a sudden on 16.9.13 he received letter contained in memo No.221 issued by B.D.O.-cum Member Secretary of Block Teachers Employment Unit Chausa, Madhepura cancelling his appointment and declaring the seat occupied by the petitioner as vacant on the ground that after enquiry it has been found that Mr. Mandal (petitioner) has obtained graduate degree from Hindi Vidyapeeth Deoghar, which is not recognized for employment of Block teacher.

A copy of Memo No. 221 dated 16.6.13 issued by B.D.O. cum Member Secretary of employment unit, communicated by H.M. of the School to the petitioner on 16.9.13 itself is annexed herewith and marked as Annexure:-4.

8. That it is an admitted fact that petitioner had been issued appointment letter on 15.6.13 vide Annexure:-2 of this application and joined on 10.7.13, which ^{was} duly accepted by the Head master of the school where he was posted.
9. That it is stated and submitted that the Govt. of India as well as Govt. of Bihar as well as State Govt. granted permanent recognition to Praveshika/Sahitya Bhushan/Sahityalankar degrees equivalent to Matriculation/ Intermediate and B.A. degrees as granted by Hindi Vidyapeeth Deoghar by different Notification issued in this regard.

So far Govt. of India is concerned, its recognition is of 18th February 1970 issued by Education and Youth Welfare Ministry ,New Delhi and of Bihar Govt. is vide order No.8/R & 303/84 dated 11.01.1991.

A copy of such recognition by

the Govt. of India, State of Bihar and such other Govt. was issued by the Registrar of Hindi Vidyapeeth Deoghar for information of general Public as well as students therein is annexed herewith and marked as annexure:-5 ~~Series~~

10. That it appears that Human Resources Development Department , Govt. of Bihar has issued a letter vide Memo No. 1346 dated 27.8.2008 issued by principal Secretary of the department mentioning therein that as per clause 4 of Bihar Zila Parishad High/Higher Secondary Education (employment & service conditions) Rules-2006 and Bihar Municipal corporation High & Higher Secondary Teachers(Employment & Service Conditions) Rule-2006 , it has been decided that different certificates issued by different Vidyapeeth as well as other such education council/College, such degree is not recognized for employment of general teacher of High & Higher Secondary schools. Including Sahityalankar -equivalent to B.A. degree granted by Hindi Vidyapeeth Deoghar.

A copy of Memo No. 1346 dated 27.8.08 issued by principal

Secretary H.R.D. Department
Govt. of Bihar is annexed herewith
and marked as Annexure:-6 to this
petition.

11. That from bare comparison of 2 letters issued by Registrar of Hindi Vidyapeeth Deoghar as well as letter dated 27.8.2008 vide Memo No.1346 by the Principal Secretary Human resources Development Department , Govt. of Bihar it is apparent that the order dated 27.8.08 vide Memo No.1346 is with regard to Zila Parishad High & Higher Secondary teachers as well as Bihar Municipal council High & Higher Secondary teachers, but so far appointment of a Prakhand Teacher is concerned it is under the provisions of Bihar Panchayat elementary teachers (engagement and Service Conditions) Rules-2006 and it is only up to class 8th education. As such the Memo no. 1346 dated 27.8.08 issued by the Principal Secretary Human resources Development Department , Govt. of Bihar is not at all applicable to appointment of a Prakhand teacher as per the aforesaid appointment Rule for elementary teacher. As such the termination letter contained in annexure-4 by the B.D.O.-cum Member Secretary Prakhand teacher employment Unit, Chausa, Madhepura is totally misconceived.
12. That it is further stated that once a criteria has been subsequently changed in year 2011 and it was mandatory that for appointment

of elementary teacher one has to pass the Bihar elementary teachers Eligibility Test, which has fixed the criteria as per Clause-7(ii) appoint^{ment} to teacher for class 6 to 8 Minimum 50% in Graduation degree or its equivalent degree has been prescribed in its prospectus and syllabus which the petitioner successfully passed and a certificate to this effect has already been issued by the B.S.E.B. as contained in annexure:-1 to this application then the issuance of letter dated 16.6.13 by the B.D.O.-cum Member Secretary Prakhand teacher employment Unit, chausa, Madhepura vide memo no.221 as contained in annexure-4 can not be held good and it is fit to be quashed.

13. That it is further stated that petitioner has been validly appointed after processing the matter as Prakhand Teacher vide appointment letter dated 15.6.2013 vide Memo No.167 issued by the B.D.O.-cum Member Secretary Prakhand teacher employment Unit, chaise, Madhepura vide Annexure-2 of this application and petitioner joined the school on 10.7.2013 and worked till 16.9.2013 then under what circumstances termination letter contained in annexure-4 on 16.6.2013 vide Memo No.221 is issued, it is beyond imagination, which is without jurisdiction and fit to be quashed.

14. That it is further stated that though the petitioner joined in the School on 10-7-2013 ^{to} ~~in~~ 16-9-2013, so salary of this period in scale

of 6000/7500/- for untrained Prakhand teacher is payable to him as per Annexure-2 itself.

15. That it is also stated that the order contained in Annexure-4 has also been passed in complete violation of principle of natural justice without giving of any opportunity of showing cause to the petitioner for his removal from the service ^{as such} the same is also nonest in the eye of law.
16. That it is further stated that the termination of the employment of the petitioner on the basis of Annexure-6 issued by the Principal Secretary Human Resources Development Department, Govt. of Bihar does not apply for appointment of elementary School teacher as such the same is also illegal and without application of mind.
17. That it is further stated that once an eligibility test for elementary school teacher has been made condition precedent for appointment of elementary teacher, which petitioner successfully passed for which necessary certificate has been issued by the B.S.E.B. Patna vide Annexure:-1 of the writ application ,which prescribed criteria for appearance for the said eligibility test held in 2011 , which was held on 30.11.2011 by SCERT, Bihar and BSEB Patna then the petitioner can not be held not eligible for holding the post of Prakhand Teacher and without taking into all these aspect of the matter the learned the B.D.O.-cum Member

Secretary Prakhand teacher employment Unit, Chausa, Madhepura issued the termination letter as contained in annexure-4 ^{to same} is totally illegal, unjustified and is fit to be quashed as invalid.

18. That under the facts and circumstances mentioned above the impugned order as contained in annexure-4 issued by B.D.O. cum- Member Secretary Prakhand teachers employment Unit Chausa, Madhepura is illegal, perverse, unjust, improper and without jurisdiction and as such is fit to be quashed by this Hon'ble Court.
19. That, under the facts and circumstances stated herein above these petitioner has got no other alternative or equally efficacious remedy than to move Your Lordships under writ jurisdiction.
20. That, the petitioner has not moved before this Hon'ble Court for the relief/s sought for in Para-1 & 2 of this writ petition on any earlier occasion.

It is, therefore, prayed that your Lordships may graciously be pleased to issue Rule NISI, calling upon the Respondents to show cause as to why the relief/s sought for in Paragraph-1 & 2 of this petition be not granted in favour of petitioner, and upon return

of rule and after hearing the parties,
make the Rule absolute.

And/or

Pass such other order/orders as Your
Lordships may deem fit and proper.

And

It is also prayed that during pendency
of this application operation and
implementation of the order impugned
as contained in annexure-4 shall remain
stayed.

And for this, the petitioner shall ever pray.
