Relief sought for:

For directing the respondents ~~the~~<sup>to</sup> accept the synopsis of the petitioner as well as for a further direction that the application which is pending before the Hon'ble Chancellor may be disposed of expeditiously.

**Date and Events:-**

November 2011 Bhupendra Narain Mandal University issued advertisement inviting applications from eligible candidate for appearing in the pre-Ph.D. Eligibility Test examination.

29.2.2012 Written test of Pre-Ph.D. Eligibility Test was conducted on 29.2.2012

7.7.2012 Result was published on 7.7.2012

12.7.2012 Marksheet was issued on 12.7.2012

11.1.2013 Petitioner filed an application on 11.1.2013 to the Head of the Department, English, B.N.M. University, Madhepura

21.1.2013 on 21.1.2013 petitioner deposited Rs.2000/- in the B.N.Mandal University being Challan no.307 dated 21.1.2013.

3.7.2013 B.N.Mandal University has decided to held 12 days special class for the selected students who passed Pre-Ph.D. Eligibility Test.

8.7.2013 Admission Semester Course was scheduled to start from 8.7.2013 to 21.7.2013

9/10.7.2013 Petitioner submitted his application to the Vice Chancellor, B.N.Mandal University, Madhepura

- dated 9.7.2013 which was received in the office of the Vice Chancellor on 10.7.2013.
- 17.7.2013 Admission Semester Course was scheduled to start from 8.7.2013 to 21.7.2013, ~~but subsequently the Dean, Students Welfare.~~
- 25.7.2013 <sup>Subsequently, the Dean, Students Welfare</sup> ~~Extended the period of the said class.~~
- 5/8.8.2013 petitioner made request to the Hon'ble Vice Chancellor that he should be permitted to submit the synopsis for Ph.D. Programme and the said application was received on 8.8.2013.
- 8.8.2013 synopsis of the Research was to be submitted, the date of which is 8<sup>th</sup> August 2013
- 12.8.2013 *Representation to Hon'ble Chancellor*
- 13.8.2013 For examining these synopsis by the expert the date was fixed for 13<sup>th</sup> August 2013.
- 14.8.2013 ~~On 13<sup>th</sup> August 2013~~ But due to death of a teacher, the same was postponed and the same was fixed on 14<sup>th</sup> August 2013

**Most Respectfully Sheweth: -**

1. That this is an application for issuance of an appropriate writ, order or direction, for directing the respondents to accept the synopsis of the petitioner for Ph.D. as well as for a further direction that the application which is pending before the Hon'ble Chancellor may be disposed of expeditiously.

2. That the substantial questions of law as involved in the present writ application are as follows:-

- I. Whether once the petitioner has passed the pre-Ph.D. Eligibility Test of 2011 held in the month of February 2012 conducted by B.N.Mandal University and thereafter admission fee for attending the special class for the Research Scholars before submission of synopsis, the respondents are justified in not accepting the Prarup (synopsis) of the petitioner?
- II. Whether once the fee of the petitioner was accepted on 21.1.2013 vide Challan no.307 for appearing in the special class and thereafter petitioner attended classes but his attendance was not marked <sup>by</sup> in which he filed petition before the learned Vice Chancellor on <sup>3</sup>~~8~~ 8.8.2013, they are justified in not accepting the Prarup (Synopsis) of the petitioner?

- III. Whether once the petitioner sent his synopsis through registered post, they are justified in not issuing registration number of the Ph.D. to the petitioner?
- IV. Whether once the petitioner filed representation before the Hon'ble Chancellor, Bihar stating all the facts, the Hon'ble Chancellor was justified in not passing any order till date on the said representation filed by the petitioner?
- V. Whether the action of respondent<sub>2</sub> authorities are malafide, arbitrary and fit to be set aside?
3. That the petitioner is citizen of India.
4. That the petitioner passed his matriculation examination from Bihar <sup>School</sup> ~~State~~ Examination Board. Thereafter the petitioner passed his I.Sc. course and thereafter petitioner filed application for permission to appear in I.A. examination and the said permission was granted and thereafter petitioner again appeared in I.A. and he passed from Ram Dayalu Singh College and thereafter petitioner passed his B.A. examination



from Erstwhile Bihar University from Niteshwar College, Muzaffarpur and thereafter petitioner passed his M.A. examination from Bihar University securing 55.5% of marks.

True copy of relevant educational certificate from matriculation to M.A. are annexed herewith and marked as Annexure-I series to this petition.

5. That the University have issued orders that for the purpose of doing the Research Course i.e. Ph.D. the applicant has to appear in the pre-Ph.D. Eligibility Test and for the purpose of appearing in the said examination a person has to secure minimum 55% of marks as per norms laid down by the U.G.C. and adopted by all the universities.
6. That in the month of November 2011 Bhupendra Narain Mandal University (B.N.Mandal University) issued advertisement inviting applications from eligible candidate for appearing in the pre-Ph.D. Eligibility Test examination.

7. That as the petitioner was fulfilling the requisite criteria, he alongwith several other persons applied for appearing in pre-Ph.D. Eligibility Test in B.N.Mandal University and as the application of the petitioner was found in order, he was given the roll number being Roll No.BNMU No.7862 and in the column of registration number which was mentioned as 00038/RNF.
8. That the written test of Pre-Ph.D. Eligibility Test was conducted on <sup>28/</sup>29.2.2012 and examination of both purpose were held on that day and petitioner appeared in the said examination.
9. That thereafter the result was published and the petitioner was declared qualified and marksheet was issued to him. The marksheet of Pre-Ph.D Eligibility Test 2011 held in the <sup>n</sup>month of February 2012, the result of which was published on 7.7.2012 and marksheet was issued on 12.7.2012.

True copy of result dated 7.7.2012 and marksheet dated 12.7.2012 are annexed herewith and marked as Annexure-3, <sup>& 3/1</sup> to this petition.

10. That the B.N.Mandal University has decided to held 12 days special class for the selected students who passed Pre-Ph.D. Eligibility Test and it was decided that from 8.7.2013 (excluding Sunday) the date for course was fixed which was notified by the Chairman (Dean), Students Welfare, B.N.Mandal University vide memo no.1741/13 dated 3.7.2013 and same was also disclosed in press release.

True copy of memo no.1741/13 dated 3.7.2013 as well as press release are annexed herewith and marked as Annexure-4 & 5 to this petition.

11. That when the petitioner came to know about the said decision, he made enquiry and learnt that for the purpose of appearing in the special class the candidates who has passed in

Pre-Ph.D. Eligibility Test has to deposit Rs.2000/- as University fee which will be known as "For Pre-Ph.D. Admission Semester Course".

12. That the petitioner filed an application on 11.1.2013 to the Head of the Department, English, B.N.M. University Madhepura that as he has passed the Pre-Ph.D. Eligibility Test he may be permitted to deposit necessary fee for attending the pre-Ph.D. Admission Semester Course.
13. That thereafter the Head of the Department English [who is now presently holds the post of Dean (Welfare)] ordered the office to verify the record and thereafter the office verified the record and office gave endorsement that the student may be permitted to take admission provisionally and may be ordered to submit their admission fee Rs.2000/- for pre Ph.D. Admissions Semester course. Thereafter on same day Head of Department of English B.N.Mandal University accept fee for admission in admission in Pre Ph D Course and took the approval without paying the application fee and accordingly on that day itself i.e. on 21.1.2013 petitioner deposited Rs.2000/- in the B.N.Mandal University being Challan no.307 dated 21.1.2013.

herewith and marked as  
Annexure-6<sup>and 6(1)</sup> to this petition.

14. That as stated above the special course which is known as Pre-Ph.D. Admission Semester Course was scheduled to start from 8.7.2013 to 21.7.2013 but subsequently the Dean, Students Welfare vide his letter dated 17.7.2013 extended the period of the said class upto 25.7.2013 and the synopsis of the Research was to be submitted the date of which is 8<sup>th</sup> August 2013 and for examining these synopsis by the expert the date was fixed for 13<sup>th</sup> August 2013.

True copy of letter dated 17.7.2013 is annexed herewith and marked as Annexure-7 to this petition.

15. That when the petitioner went to attend the class, his attendance was not being marked <sup>either</sup> on 8.7.2013 and 9.7.2013, he submitted his application to the Vice Chancellor, B.N.Mandal University, Madhepura dated 9.7.2013 which was received in the office of the Vice Chancellor on 10.7.2013.

True copy of representation dated 9.7.2013 is annexed herewith and marked as Annexure-8 to this petition.

16. That petitioner was directed to attend the class of aforesaid Pre-Ph.D Admission Semester from 8.7.2013 to 25.7.2013 but for the reasons best known to the authorities his attendance was not marked although as the petitioner has learnt the Hon'ble Vice Chancellor on application of the petitioner dated 9.7.2013 which was received on 10.7.2013 has called for the report but no order has been communicated to the petitioner and till date no final order has been communicated to the petitioner by the Vice Chancellor of B.N.Mandal University, Madhepura .
17. That it is important to mention here that as attendance of the petitioner was not marked in the Pre-Ph.D Semester, petitioner was told that his synopsis will not be accepted and accordingly vide letter dated 5.8.2013 the petitioner made request to the Hon'ble Vice Chancellor that he should be permitted to submit

the synopsis for Ph.D. Programme and the said application was received on 8.8.2013.

True copy of letter dated 5.8.2013 is annexed herewith and marked as Annexure-9 to this petition.

18. That the petitioner went to submit his synopsis on 8.8.2013 and the Head Of the Department has said that no receiving will be given in proof of submitting of synopsis and thus petitioner handed over one copy of synopsis to the Head of the Department English and on the same date another synopsis was sent through registered post to the Head of the Department English, B.N.Mandal University through registered post for which total cost realized by the post office was Rs.22/-.

True copy of postal receipt sent to the Head of Department of English, B.N.Mandal University on 8.8.2013 is annexed herewith

and marked as Annexure-10 to this petition.

19. That thereafter the petitioner has learnt that his synopsis was not even placed before the Expert for discussion in the meeting of Departmental Research Council. It is important to mention here that vide annexure-4 the date of holding the Departmental Research Council was fixed on 13<sup>th</sup> August 2013 but due to death of a teacher the same was postponed and the same was fixed on 14<sup>th</sup> August 2013 in the Library Hall and on 14.8.2013 petitioner was present alongwith his synopsis but no question were put to him.
20. That thereafter petitioner filed representation on 12.8.2013 before the Hon'ble Chancellor –cum-Convenor of Bihar which was also sent through post.

21. That till date no decision has been communicated either by the Vice Chancellor, B.N.Mandal University or by the Hon'ble Chancellor, Bihar, Patna
22. That it is important to mention here that when petitioner deposited the fee for attending the pre-Ph.D. Admission Semester Course he was 7<sup>th</sup> or 8<sup>th</sup> in number.
23. That it appears that as the petitioner has attended his M.A. and other educational qualification from B.R.A. Bihar University the erstwhile Bihar University, due to that reason he is being discriminated.
24. That the petitioner has already passed the examination of Pre-Ph.D. Eligibility Test, 2011 for doing Research in English and thus he is entitled to be enrolled as Research Scholar but for the reasons best known to the authority he is not being permitted to do so.
25. That petitioner seeks the following reliefs:-
  - (A) The respondents be directed to approve and accept the synopsis of the petitioner.

- (B) The Respondents be directed to allot a guide to the petitioner for his Research Work in English so that petitioner may complete his thesis.
- (C) Any other relief/reliefs be granted to the petitioner to which he is found to be entitled to.
26. That from the aforesaid facts it is clear that the action of the respondent authority is arbitrary, mala fide and is fit to be set aside.
27. That the petitioner has got no other alternative and efficacious remedy than to move to this Hon'ble Court for redressal of his grievance.
28. That the petitioner has not moved to this Hon'ble Court earlier for the relief as prayed for in this application.

It is therefore, prayed that your Lordships may graciously be pleased to admit this application, issue rule NISI calling upon the respondents to show cause as to why the relief sought for in paragraph no.1 and 25 of this application be not allowed and upon

return of the rule and after hearing the parties if no sufficient cause is shown be pleased to make the rule absolute.

And/or

Pass such other order or orders, as your Lordships may deem fit and proper.

And

During pendency of this application your Lordships be pleased to stay the operation of the impugned ~~order~~<sup>Result</sup> as contained in Annexure-3.

And for this, the petitioner shall ever pray.

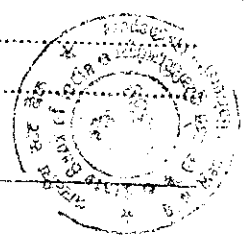
