**Supplementary Affidavit on behalf of the
petitioner.**

I, Ramesh Jha, aged about years, sons of
late Raghunath Jha, resident of village Sihpur,
Police Station Kumarkhand, District Madhepura,
do hereby solemnly affirm and state as follows:-

1. That I am Secretary of the Managing Committee of Atma Samarpan Middle School, Bhokraha and as such am well acquainted with the facts and circumstances of the case.

2. That it is respectfully submitted that the policy decision of 1993, a copy of which has not been made available to the petitioner despite his best efforts, is arbitrary, unreasonable and unconscionable. As and when made available, the petitioner would furnish a copy of the same. However, on the basis of the alleged decision of 1993, impugned press release has been made, which are equally arbitrary, unjust and in teeth of Article 14 of the Constitution of India and without any authority of law.

3. That admittedly the present school has its special features recognized by the Government leading to the Notification in 1998 itself. Its preservation, maintenance and improvement are imperative. The respondent, while denying the due benefits to the petitioner, are bent upon liquidating and extinguishing the very existence of the school which is now functioning for several decades under the authority of the Government. It is painful to state that the Director, Primary Education in terms of his order dated 7.10.2006 directed the District Education Officer to open other schools in the vicinity so as to make the present school extinct. Similarly, the Deputy Director, Elementary Education in terms of his order dated 11.4.2007 has directed the

District Education Officer to open schools in the vicinity so that the students of the present school may migrate there. The respondents are determined to cause prejudice to the petitioner. While the door to open the other middle schools in the vicinity is open, the petitioner has illegally been discriminated against.

4. That the contents of this Supplementary Affidavit have been read over and explained to me in Hindi whom I have fully understood and I state that they are true to the best of my knowledge and belief.


