.Most Respectfully Sheweth ;-----

1. That this application is being filed for initiating the proceeding of contempt of court against the Opposite parties for willfully and deliberately bypassing/violating/disobeying the order of this Hon'ble court dt 30/08/2012 passed by Hon'ble Mr. Justice Prakash Chandra Verma in C.W.J.C no-12305/2012 as contained in Annexure-1
2. That the petitioner had filed a writ petition before this Hon'ble High Court vide C.W.J.C no-12305/2012 which was disposed of by Hon'ble Mr Justice Prakash Chandra Verma, directed the respondent no---5 to decide the matter within a period of two months from the date of receipt /production of a certified copy of this order his appeal filed by the petitioner .

petition .

- 3 That the fact of this case is that the petitioner has been working on the post of Anganbari Sevika in Madhya Tola Centre --06 Babhangama , Block --- Bihariganj District --- Madhepura since 1984 .

4. That the petitioner has been working very satisfactorily and the work of the petitioner has been appreciated and rewarded time to time. The petitioner has been performing her duty of sevika with devotion and dedication to achieve the goal of children welfare.
5. That the I.C.D.S emphasizes over the **social welfare scheme** through the anganari centres and the active workers and Govt has decided to appoint the Anganbari Supervisor by direct appointment as well as by promotion of Sevikas for monitoring the anganbari centres and sort out the problems in anganbari centres and also to solve them.
6. That pursuant to the advertisement no- 1/I.C.D.S./1068/01/875/Sak dt. 14/06/2010 applied for the post of Anganbari Supervisor through on line and also submitted all the required papers to the respondent of the concerned Block on 16/07/2010.
7. That the petitioner applied for the post of Supervisor and a list of candidates have been made and the petitioner got her name placed at serial No—05 of the formal merit list by the selection committee.
8. That the respondents set over the matter for indefinite period and no information with regard to selection or non selection of Anganbari Sevika on the post of Supervisor was given.

9. That the petitioner made effort to get the information with regard to selection of Super visior but no information was given .
10. That the petitioner obtained the final merit list selected by the selection Committee on 01/07/2011 through office in he month of February 2012 in which her name was not found place in the merit list for promotion on the post of Anganbari Supervisor.
11. That the respondent No-6 the D.P.O Madhepura by his letter no—769dt. 22/06/2011 rejected the petition of the petitioner alleging her selection has been made in underage.

herewith and marked as
Annexure -2 to the petition.

12. That the respondents had not given any opportunity of hearing to the petitioner on the matter of non selection on the post of Aganbari sevika in underage and without any information or letter her selection has been denied.
Ultimately the petitioner went to the office of the respondents to know the facts but the respondents don't entertain her

13. That the petitioner has given a letters to the respondents for her grievance but no steps have been taken by them.

14. That the letter no- 731 dt 24/02/2012 issued by the Secretary Deptt of Social Welfare, Bihar, Patna directed the Collectors to promot the Anganbari Sevika who have been appointed earlier in underage.

A true photocopy of the letter no-731 is annexed herewith and marked as annexure no-3 to the petition.

15. That the Anganbari Sevikas of different Blocks of Purnea District and other Districts of Bihar who has been appointed in underage have been promoted on the post of Anganbari Supervisor and now they are working on the said post since 30/03/2012 .

16. That the petitioner filed a appeal before the Collector on the direction of this Hon'ble High Court on 02/11/2012 after obtaining the order of this Hon'ble High Court on 15/09/2012.

A true photocopy of appeal is annexed herewith and marked as Annexure-4 to this petition.

17. That the appeal was admitted on 16/11/2012 and on several occasions the petitioner appeared before the learned Collector respondent No-5 uptill 14/06/2013 but order was not passed.

A true photocopy of the proceeding is annexed herewith and marked as A---5 to this petition .

18. That the respondent No---6,7&8 on the direction of the Collector harassing the petitioner mentally to go on the Anganbari centre without any occasion and misbehaved with the petitioner being known to the petitioner is helpless .
19. That it is hereby submitted that the respondents /opposite parties No---5to8 are deliberately and intentionally harassing the petitioner by calling on different dates of appeal and as such the opposite parties No---5 to 8 are deliberately and intentionally violating the order of the Hon'ble High court dt. 30/08/2012 .
20. That the opposite Parties No—5 to 8 with a harassing attitude had deliberately and intentionally not hear the appeal and on the order of the respondent No---5 to the respondent No-6&8 not appearing before the Collector with the entire paper of selection which is apparent from the proceeding paper (contained A---5).
21. That it is submitted that the Hon'ble Court directed the respondent No—5 to decide the matter within a period of two months from the date of the receipt /production of a

certified copy of this order but the opposite party No---5 deliberately and intentionally violating the order of this Hon'ble High Court having no fear for any consequences .The petitioner is suffering a lot due to negligence of the rules of the I.C.D.S. by the respondents .

22. That the petitioner has not moved earlier before this Hon'ble High Court for the present subject matter.

It is therefore, prayed that your Lordships may graciously be pleased to initiate a proceeding of contempt of court against the opposite parties and punish them for their deliberate and intentional act of Ommission and violation of this Hon'ble High Courts order dt. 30/08/2012 .

And

Pass such other order ororders as your lordships may deem fit and proper.



3. That an scheme of the government of Bihar from Welfare Department came for the appointment on he post of Anganbari Supervisor

4. That the appellent applied for the post of
Anganwari Supervisor through on line on 16.07.2010.

5. That after full verification of the papers
of this appellent, the name of this appointment was
~~placed~~ placed in the merit list dated 01.07.2011.

6. That here was reservation of 25% seat for the
candidate of Anganwari Sevika for the post of
Supervisor but it is most unfortunate that the promo-
tion of the appellent from the post of Anganwari Sevika
to Anganwari Supervisor could not be made only due to
wrong letter of the Chief Secretary of I.C.D.C.
Department , Patna vide letter no. A.K. vide 60-114/10
Dept. letter no. 3672 dated 23.08.2010 issued on
17.01.2011.

petition (C.W.J.C.) before the Hon'ble High Court, Patna vide C.W.J.C. no. 12305/2012 which was disposed of on 30.08.2012 and thereby this appellatant has been directed to file an appeal before the Collector, Madhepura the same shall be decided within the period of two months form the date of receipt or production of the certified copy of this order dated 30.8.2012 .

That in obedience to the direction of the Hon'ble High Court dated 30.8.2012 this appellatant has already producted the certified copy of the order dated 30.8.2012 passed by the Hon'ble High Court, Patna in C.W.J.C.No.12305/12, on 26.09.2012 in your Honour's Office along with her written application in Shape of Anganwari Appeal, which is available in your Honour's Office.

9. That in supplementary of the written application filed by this appellatant dated 26.9.2012, the detailed facts are being placed in this misc. appeal of Anganbari .

G R O U N D S

(I) For that the impugned order of the D.P.O.

Madhepura regarding non-promotion of this appellant from the post of Anganwari Sevika to Anganwari Supervisor dated 22.6.2011 through memo no.769 issued on 19.6.2011 is illegal, irregular and incorrect and the same is fit to be set aside.

(ii) For that the learned D.P.O. (ICDS) Department should have considered that the actual age for the appointment of the candidate on the post of Anganwari Sevika was 15-44 year but not 18 years as per provision in the rule of I.C.D.S. as Annexure-(II) which is illegal.

(iii) For that the learned D.P.O. should have considered the facts mentioned in Register No. 731 dated 24.02.2012 issued by the Secretary , I.C.D.S. Patna to all the District Officers in which it has been well mentioned in the departmental letter No. S.K Misc. 60-114/10 B 1 dated 17.01.2011 which has been annexed here, in which the actual age of Anganwari Sevika was below 18 years but that has not been considered.

(iv) For that there are other grounds also which

shall be placed at the time of hearing.

Under the above facts and circumstances it is prayed humbly that your Honour would be kind enough to admit this appeal, to stay the further proceeding, to notice the parties to call for the record concerned from the office of D.P.O. (I.C.D.S.) Department Madhepura and after hearing both the parties be further pleased to set aside the impugned order of non promotion of the appellant from the post of Anganbari Sevika to Anganwaari Supervisor and to order for promotion of this appellant from the post of Anganbari Sevika to Anganbari Supervisor for ends of Justice;

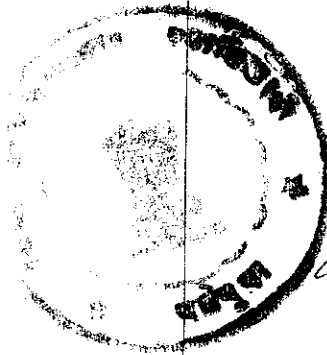
