MOST RESPECTFULLY SHEWETH:-

1. That, this is an application on behalf of the petitioner above
named is for initiation of a contempt proceedings against the contemnors -
Opposite -parties ,who have deliberately and willfully did not comply
the order dated 02.04.2012 passed by His Lordship Hon'ble Mr. Justice
Kishore Kumar Mandal in C.W.J.C. No.3371 of 2012 within the stipulated
period .

No. 3371 of 2012 is annexed hereto
and marked as ANNEXURE- "1" to

this application.

2. That, the petitioner had filed the instant writ application for payment of arrears of salary .

3. That, after hearing the parties , a bench of this Hon'ble Court disposed of the writ application with a direction to the petitioner to file representation supported by all relevant documents within five weeks and thereafter contemnor –Opposite-parties examined the claim of the petitioner and to take appropriate decision in accordance with law as quick as possible preferably within a period of two months from the date of filing /presentation. The Contemnors-Opposite-parties were also directed to take all effective steps to ensure authorization of the admissible dues within further period of three months based on the decision taken by them on the representation of the petitioner .

4. That, the petitioner after getting the certified copy of the order dated 02.04.2012 passed in C.W.J.C. No.3371 of 2012 represented before the contemnor-Opposite-party nos.2 and 3 on 30.04.2012.

True photo stat copies of the representations dated 30.04.2012 are annexed herewith and marked as ANNEXURE- "2" & "2/1" to this application.

5. That, the petitioner visited several times for getting his arrears of salary before the contemnors-Opposite-parties but only assurance was given by him but till today not a single pany has been paid to the petitioner , it amounts to deliberate intention to harass the petitioner as well as deliberate disobedience to comply the order of this Hon'ble Court.

6. That, the aforesaid action of the contemnors- Opposite-parties is willful and deliberate and thus there appears to be no respect of this Hon'ble Court before the contemnors -Opposite-parties for which they are liable to be prosecuted and appropriately sentenced under the Contempt of Court's Act .

7. That, the petitioner has not filed any application like the present one earlier before this Hon'ble High Court .

It is ,therefore, most humbly prayed that your Lordships may graciously be pleased to issue notice to the contemnors-opposite parties ,calling upon the show-cause as to why contempt proceeding should not be initiated for violation of the court's order (ANNEXURE-1) and if no sufficient cause is shown Your Lordships may further be pleased to prosecute the contemnors - opposite parties under the contempt of court's

Act and they may be sentenced appropriately.

Heard learned counsel for the petitioner and the
Accountant General.

Today I have disposed of an application filed by the
present petitioner seeking appropriate direction upon the
respondents to pay the post retiral dues. The present application
seeks a direction upon the respondents to pay his arrears of salary
for the period spelt out in sub paras (a) to (e) of para 1 of the writ
petition.

Learned counsel submits that he filed representation
raising the aforesaid grievance before the appropriate authority of

the State respondent including the Principal Secretary, Department of Health and Family Welfare (respondent no.2) but no heed was paid leading to filing of the present writ petition. Learned counsel submits that petitioner would be satisfied if the present application be also disposed of permitting him to file appropriate representation raising the aforesaid grievance before the respondent Principal Secretary as well as the Civil Surgeon cum Chief Medical Officer, Madhepura (respondent no.7) who may be directed to examine the same and take appropriate decision in accordance with law. Learned counsel submits that in the application filed by the petitioner seeking payment of post retiral dues which has been disposed of today the matter has been directed to be raised before those two respondents.

Learned AC to SC-21, in view of the aforesaid stand taken by the petitioner, states that the matter may be disposed of in the terms suggested by the petitioner.

In my view, for expeditious settlement of the claim(s) of the petitioner, the matter be disposed of by the following order:-

Let the petitioner file a representation detailing the aforesaid grievance(s) together with a copy of the present order before the Principal Secretary, Department of Health and Family

Welfare (respondent no.2) as well as the Civil Surgeon –cum- Chief Medical Officer, Madhepura (respondent no.7) within a period of 05 weeks whereafter those two respondents, acting in tandem, would examine the claim(s) of the petitioner and take decision thereon in accordance with law as quickly as possible preferably within a period of 03 months from the date of filing/presentation. Depending upon the decision to be taken on the said representation the respondents will thereafter take all effective steps/measure to ensure that these dues on account of arrear of salary is/are authorized in favour of the petitioner within a further period of 05 weeks.

- (घ) गुप इन्स्योरेश पालिसी का भुगतान नहीं हुआ है,
- (ङ) सामान्य भविष्य निधि लेखा संख्या - BHR/BHS- 4508 में संचित राशि की अंतिम निकासी नहीं हुई है।

5. उपर्युक्त वर्णित सभी दावों के लिये मैंने उच्च न्यायालय पटना में निमांकित दो समादेश याचिकाये दायर की थी:-

- (1) CWJC NO:- 2287/2012 पूर्ण सेवानिवृत्त लाभ हेतु तथा
- (2) CWJC NO:- 3371/ 2012 कार्यावधि के वकाये/लंबित वेतनदि भुगतान हेतु
