The Hon'ble Ms. Rekha M. Doshit, the Chief Justice of the High Court of Judicature at patna and her companion Justices of the said Hon'ble Court.

The humble petition on behalf of the petitioner above named.

Most Respectfully Sheweth :-

- 1) That this is an application for issuance of Rule of contempt against the contemnors/ opposite parties named hereinabove for their willful, deliberate, intentional

disobedience of the Judgement, order/ directions of this Hon'ble court in C.W.J.C.No. 7631 of 2008 passed by Hon'ble Mr. Justice J.N. Singh on 08.08.2011 whereby and where under this Hon'ble court inter- alia has been pleased to pass following orders –

“this writ application is disposed of with a direction to the Block Development officer/ concerned authority to transmit the complaint/representation of the petitioner along all the connected records to the statutory Appellate Authority within one month from the date of receipt/production of a copy of this order. On receipt of the records, the Appellate Authority shall issue notice to the concerned parties giving them opportunity to be heard, call for the original records, if necessary, and shall decide the matter in accordance with law on merits, without going into the question of limitation preferably within three months from the date of receipt of records from the office of the concerned authority. ”

A true copy of the order dtd.08.08.2011 passed in C.W.J.C.No. 7631 of 2008 is being annexed herewith and marked as ANNEXURE-1 to this petition.

- 2) That it is stated that pursuant to the order dtd. 08.08.2011 (Annexure-1) the petitioner submitted a detailed and exhaustive representation before the opposite party no.4 on 06.09.2011 annexing therewith the copy of the order passed by this Hon'ble Court as Contained in Annexure-1.

A true copy of petitioner's representation dtd. 06. 09.2011 is annexed and marked as ANNEXURE-2 to this petition.

- 3) That after completing the necessary formality of selection, the petitioner was initially appointed as " panchayat Teachewr" in Primary School (Urdu) Lakshmania under Panchayat- Jhitkia, Block- Ghailarh, District- Madhepura.

A true copy of appointment letter dated 03.06.2007 is annexed herewith and marked as ANNEXURE-3 to this petition.

- 4) That it is stated that after the said appointment of the petitioner she served in the aforesaid school for more than five months. It is pertinent to mention here that on 19.11.2007, when the petitioner went to the said school, the then opposite party no.9 restrain her to discharge her duties by saying that the appointment of the petitioner on the post of "Panchayat Teacher" has now been cancelled by the opposite party no. 10.
- 5) That it is stated that being aggrieved with the said fact, the petitioner submitted a detailed representation before the opposite party no.2 on 20.12.2007, but he had preferred to sit tight over the matter causing serious prejudice to the petitioner.

A true copy of representation dtd. 20.12.2007 is annexed and

marked as ANNEXURE-4 to this petition.

- 6) That it is stated that due to the said inaction on the part of opposite party no.2 the petitioner was compelled to move before this Hon'ble court in the connected writ petition for the redressal of her grievance, which came to be decided vide Annexure-1 to this application.
- 7) That since the grievances of the petitioner remained unsettled by the opposite parties concerned as such on 06.02.2012, the petitioner submitted reminder representation before the opposite party no.4 for getting her said grievances settled but of no avail.

A true copy of representation dtd. 06.02.2012 is annexed and marked as ANNEXURE-5 to this petition.

- 8) That it is needless to mention here that as per the order of this Hon'ble court, the contemnor/ opposite parties were under

obligation to comply with the order of this Hon'ble court as contained in Annexure-1 on or before 08.12.2011 which they did not do. The said action of the opposite parties concerned amount to gross contempt for which they deserve suitable prosecution followed with severe punishments.

- 9) That the contemnor/ opposite parties willfully knowingly and intentionally are not complying with the order of this Hon'ble court as such the contemnor/ opposite parties deserve suitable prosecution and punishment for disobeying of the order of this Hon'ble Court.
- 10) That the petitioner has not moved any other contempt petition against the order dtd. 08.08.2011 passed in C.W.J.C.No.7631 of 2008 by Hon'ble Mr. Justice J.N. Singh.

It is, therefore, humbly prayed that your Lordships may graciously be pleased to admit this application, issue notices to the contemnors/ opposite parties to show-cause as to why they be not prosecuted and

punished for willful, deliberate and flagrant violation of the order dtd.

Passed by Hon'ble Mr. Justice J.N. Singh in C.W.J.C.No.7631 of 2008, and after hearing the parties, suitably punish and sentence the opposite parties and / or pass such other order or orders as your Lordships may deem fit and proper in the facts and circumstances of the case.

And for this, the petitioner shall ever pray.

Petitioner was appointed as Panchayat Teacher in 2007. However, by subsequent order, she has been restrained from working as such and she has received

information that respondent no.11 has been appointed in her place.

The submission of the learned counsel for the petitioner is that respondent no.11 had not participated in the Counselling and, therefore, her appointment was out and out illegal. It is pointed out that petitioner filed a complaint before the competent authority vide Annexure-5 and also sent a legal notice to the Block Development Officer, Ghailarh, District Madhepura, vide Annexure-6, with copies to all concerned. However, it is submitted that no final decision has been taken by the respondents in the matter till now.

After creation of the statutory Appellate Authority as per 2008 Amendment in the Rules, Government officials have been divested off the powers to entertain any complaint and pass orders in respect of employment or otherwise of Panchayat Teachers and all pending matters in respect of Shiksha Mitra also.

As from the records it appears that the complaint of petitioner has not

been disposed of by the authorities, this writ application is disposed of with a direction to the Block Development Officer/concerned authority to transmit the complaint/representation of the petitioner along all the connected records to the statutory Appellate Authority within one month from the date of receipt/production of a copy of this order. On receipt of the records, the Appellate Authority shall issue notice to the concerned parties giving them opportunity to be heard, call for the original records, if necessary, and shall decide the matter in accordance with law on merits, without going into the question of limitation preferably within three months from the date of receipt of records from the office of the concerned authority.

Sir,

With regard to the captioned subject matter, I beg to submit before you that in view of the said order dated 08.08.2011 passed by Hon'ble High Court, Patna in C.W.J.C. No. 7631 / 2008, you are obliged to send my all the connected records in connection, with my appointment to the post of 'Panchayat Teacher" at Primary School (Urdu), Lakshmania Panchayat - Jhitkia Block - Ghailarh, Dist. - Madhepura to the concerned Statutory appellate authority within one month from the date of receipt of the said order.

The Brief facts giving enlist filling of the case in hand is that I was appointed as a "Panchayat Teacher" as primary school (Urdu). Lakshmaniya under Panachayat Jitikia by the appointing committee by letter No. 04-1 dated 03.6.2007. Due to summer vocation, I initially joined at the office of the concern panchayat on 03.06.2007 and thereafter joined in the above said school on 02.07.2007. Your honour, I worked in the said school till 18.11.2007 and have marked my attendance in the prescribed attendance register also. But on 19.11.07, when I went to the said school the then "Head Master" of that school restrain me to perform my duty by saying that my appointment on the post of "Panchayat Teacher' has new been cancelled by the then 'Mukhia' of the concern Panchayat. On enquiry, I received information that one 'Mrs. Nikhat Banoo' W/o Afroz, Mahua Tola under the same Panchayat has now been appointed in the place of me, whereas the same had not even participated

in the process of counselling. Hence she could have not been appointed on the post in question. being aggrieved, I sent an representation on 20.12.2007 to the authorities concerned and also a pleader notice was sent on 30.12.2007 to the then B.D.O., Ghailarh to seek remedy but of no consequences. Under such circumstances, I had to move before the Hon'ble High Court, Patna in C.W.J.C. no. 7631/2008 for redressal of my said grievance which has been disposed of by the said order dated 08.08.2011.

Hence you are requested to take the step of your respective part so that the said order of the Hon'ble High Court, Patna may be complied with in its true letter & spirit and hope it finds your kind favour.

यथा, इसके बाद अखबार में प्रकाशित विज्ञप्ति के अनुसार मैं संबंधित पंचायत में कॉन्सिलींग में उपस्थित हुई और संबंधित पंचायत के मुखिया एवं पंचायत सेवक की उपस्थिति में मेरा कॉन्सिलींग सम्पन्न हुआ और प्रदत्त रजिस्टर में मुझसे हस्ताक्षर करवाके मेरी उपस्थिति दर्ज कराई गई।

यथा, इसके बाद शिक्षक नियोजन-समिति द्वारा कथित पंचायत के मुरिलम-कोटि के मेधा सूची को तिथि- 25.04.2007 को जारी किया गया जिस सूची में मेरा नाम "रहमती बानो" पिता- मो० अनवर आलम क्रमांक संख्या- 9 पर है। (छाया प्रति- संख्या- A संलग्न)

यथा, नियोजन-समिति द्वारा विभागीय पत्रांक/ज्ञापांक संख्या- 04-1 तिथि 03.06.2007 को अधोहस्ताक्षरी पंचायत सचिव ने मुझे सूचित किया कि मेरा नियोजन ग्राम पंचायत झिटकिया के अन्तर्गत प्रा०वि० उर्दू, लक्ष्मीनियाँ में पंचायत शिक्षिका के पद पर कर लिया गया है जो कि बिहार प्रारंभिक शिक्षक (नियोजन एवं सेवा शर्त) नियमावली 2006 के अनुरूप है।

यथा, तदनुपरांत मैंने कथित विद्यालय में ग्रीष्मावकाश रहने के कारण पंचायत- सचिव के कार्यालय में तिथि 03.06.2007 को अपना योगदान दिया तथा वहाँ से 02.07.2007 को अपने मूल विद्यालय में योगदान देने हेतु विरमित हुआ।

यथा, मैं पूरी निष्ठा से विद्यालय में अपने कर्तव्य व दायित्व का पालन करने लगी। दिनांक- 19.11.2007 को जब मैं अपने उक्त विद्यालय गई तो मुझे संबंधित विद्यालय के प्रधानाध्यापक महोदय ने कार्य करने नहीं दिया। मुझे शिक्षिकोपस्थिति पंजी में भी हस्ताक्षर करने नहीं दिया गया। कारण पूछने पर मुझे मौखिक रूप से कहा गया कि आपका नियोजन संबंधित ग्राम पंचायत के मुखिया जी के द्वारा निरस्त कर दिया गया है और आपके स्थान पर "निखत बानो" पति अफरोज पता महुआ टोला, झिटकिया पंचायत, घैलाढ़ (मधेपुरा) को नियोजित कर लिया गया है।

यथा, महाशय, आज के तिथि तक मुझे कहीं से भी कोई अधिकृत/लिखित सूचना नहीं मिली है कि मेरा नियोजन निरस्त कर दिया गया है। अतः मुझे अंदेशा है कि एक सोची-समझी साजिश के तहत मुझे कार्य से पृथक रखा गया है। जिसमें निसंदेह प्रधानाध्यापक, मुखिया, पंचायत सेवक की मिली-भगत है।

यथा, प्रधानाध्यापक, प्रा०वि० उर्दू लक्ष्मीनियाँ के अनुसार कथित निखत बानो पति अफरोज का नियोजन मेरे स्थान पर नियोजन-समिति के सर्व-सम्मति से लिए गए निर्णय के अनुसार किया गया है। तो मेरी याचना है कि विधिक प्रक्रिया का अनुपालन करते हुए नियोजन-समिति की

बैठक हुई होगी जिसमें निर्णय ले कर मेरा नियोजन निरस्त किया गया होगा साथ ही इसकी सूचना उच्च-पदाधिकारी को भी दी गई होगी तो महाशय ऐसी-किसी कार्यवाही-पंजी एवं बैठक की तिथि का अवलोकन आपके स्तर से किया जाना अपेक्षित है। मैं यहाँ ध्यान आकृष्ट करना चाहूँगी कि ऐसी प्रक्रिया की सूचना मुझे भी नहीं दी गई है।

यथा, महानुभाव प्रस्तुत आवेदन में संलग्न छाया प्रति संख्या-A का अवलोकन किया जाना प्रासंगिक जान पड़ता जो पंचायत के शिक्षक नियोजन-समिति के द्वारा मुस्लिम कोटि के मेधा-सूची को 25.04.2007 के प्रभाव से जारी किया गया है और उल्लेखनीय है कि इसमें कथित निखत बानो का नाम उल्लिखित नहीं है।

यथा, मैं अपने विद्यालय में 08.11.2007 तक निरंतर हाजरी बनाती रही हूँ इसके बाद 19.11.2007 के प्रभाव से अपने कार्य से वंचित हूँ। बीच की अवधि 09.11.2007 से 18.11.2007 तक विद्यालय में दिवाली, छठ पूजा का अवकाश था। (छाया प्रति संख्या-E संलग्न)

यथा, महाशय, मैंने कथित विद्यालय में प्राथमिक शिक्षिका के पद पर पाँच महीना से ज्यादा काम किया है। अतः पाँच महीना से ज्यादा बीतने के उपरांत मुझे कार्य से विलग/पृथक करना यह दर्शाता है कि संबंधित पंचायत में शिक्षक नियोजन-समिति द्वारा मनमानापूर्ण, स्वेच्छारी, एक-पक्षीय रवैया अपनाया जा रहा है जो कि कहीं से भी स्थापित कानून के अनुकूल नहीं है और प्राकृतिक न्याय के प्रतिकूल है।
