Prayer

For issuance of rule of contempt against the Opp. Parties for suitable convict them for disobeying the order dt. 27.07.2007 passed by Hon'ble Mr. Justice Mihir Kumar Jha, passed in CWJC No. 14223/ 2004 by which directed to consider the case of the petitioner as similarly situated like petitioner has been granted benefits to the petitioner regarding due payment of the salary and and further issue specific direction to undue the breach of the order dated 27.07.2007.

Connected writ application filed by the husband of the petitioner Late Ram Sevak Poddar regarding payment of due salary since January 1995 to till date of his superannuation on 31.01.2000 as well as the period from 01.02.2000 to 08.06.2001, during the said period her husband was worked before the respondents.

- 31.01.2000 Petitioner was posted as Manager at Puraini PACS, till date of retirement and have worked till 08.06.2001 with permission of the Managing Director of the said Bank.
- 01.11.07 Husband of the petitioner also filed an application before District Cooperative Officer, Saharsa cum Assistant Liquidatory Madhepura Supaul Central Cooperative Bank Ltd. on 01.11.2007 along with the detail due salary of the petitioner but did not consider and not complied the order of this Hon'ble Court as yet.
- 24.10.2008 Petitioner filed application before the respondent along with the order of this Hon'ble Court dt. 24.10.2008 before District Magistrate, Madhepura cum Liquidator Madhepura Supaul Central Cooperative Bank Ltd. regarding payment of the due salary
- 12.08.11 Petitioner filed application on 12.08.11 before Principal Secretary, Cooperative Department, Bihar, Patna
- 31.03.2013 Husband of the petitioner, the petitioner could not provided proper treatment in the result, her husband died on 21.03.2013, left behind petitioner's widow and two sons who are unemployed.

petitioner also suffering from illness, by the several old diseases, she is not able to treatment due to scarcity of the money, two sons are also unemployed meaning thereby, the family members of the Late Ram Sevak Poddar are suffering from starvation where the payment of due salary before the respondents/ opposite parties thus, they are liable to interest 18% till date of full and final payments.

Hence this writ application.

2. That connected writ application filed by the husband of the petitioner Late Ram Sevak Poddar regarding payment of due salary since January 1995 to till date of his superannuation on 31.01.2000 as well as the period from 01.02.2000 to 08.06.2001, during the said period her husband was worked before the respondents.

3. That the husband of the petitioner was posted as Manager at Puraini PACS, till date of retirement and have worked till 08.06.2001 with permission of the Managing Director of the said Bank.

4. That husband of the petitioner also filed an application before District Cooperative

Officer, Saharsa cum Assistant Liquidatory Madhepura Supaul Central Cooperative Bank Ltd. on 01.11.2007 along with the detail due salary of the petitioner but did not consider as yet.

A true photo copy of the application dt. 01.11.07 along with detailed bills/ of the husband of the petitioner is annexed as Annexure - 2 to this application.

5. That aforesaid writ application disposed of by this Hon'ble Court dt. 27.07.2007 there after, husband of the petitioner filed application before the respondent along with the order of this Hon'ble Court dt. 24.10.2008 before District Magistrate, Madhepura cum Liquidator Madhepura Supaul Central Cooperative Bank Ltd. regarding payment of the due salary but respondent authority did not consider the matter of the petitioner.

A true photo copy of representation dt. 24.10.2008 is annexed as Annexure -3 to this application.

6. That further husband of the petitioner filed application on 12.08.11 before Janta Darbar to the name of the Principal Secretary, Cooperative Department, Bihar, Patna for compliance of the order passed in CWJC No. 14223/2004 regarding due salary and family pension.

A true photo copy of application dt. 12.08.11 is annexed as Annexure - 4 to this application.

7. That payment of due salary and family pension of the husband of the petitioner, the petitioner could not provide proper treatment in the result, her husband died on 21.03.2013, left behind petitioner's widow and two sons who are unemployed.

A true photo copy of Death Certificate dt. 31.03.2013 is annexed as Annexure - 5 to this application.

8. That husband of the petitioner died, due to not proper treatment for scarcity of the

money for which her husband requested several times but respondent authority did not take any action regarding payment of due salary as directed by this Hon'ble Court.

9. That petitioner also suffering from illness, by the several old diseases, she is not able to treatment due to scarcity of the money, two sons are also unemployed meaning thereby, the family members of the Late Ram Sevak Poddar are suffering from starvation where the payment of due salary before the respondents/ opposite parties thus, they are liable to interest 18% till date of full and final payments.

10. That soon after death of her husband , she filed application but till today , case of her husband has not complied as yet.

11. That opposite party have no regard of the order of this Hon'ble Court.

12. That the opp.parties has no regard the order passed by this Hon'ble Court and they are deliberately violating the order of this Hon'ble Court.

13. That on the above facts and circumstances of the case, petitioner deserve relief by this Hon'ble Court.

14. That petitioner has not move before this Hon'ble Court any time earlier for the relief sought for in this application except and otherwise mentioned in this application.

It is, therefore, prayed that your lordships may graciously be pleased to issue notice to show cause as to why the contempt be not initiated against the opp.parties for violation of the order of this Hon'ble Court and after cause being shown if any, and after hearing the parties pass such other order/orders as your lordships may deem fit and proper in the facts and circumstances of the case.

And for this the petitioner shall ever pray.

The petitioner, a Paid Manager, an employee of Madhepura – Supaul Central Cooperative Bank Ltd. claims his retirement benefits on the terms that he having worked for a period of 28.07.94 to his date of retirement-in 31.01.2000, is entitled for certain benefits including the arrears of salary and/ or any retrial benefits. There is a statement of the petitioner which has been recorded in this very proceeding earlier that the bank in which he was paid Manager has gone under liquidation and that he had filed application before the Liquidator for claiming such dues as is admissible to him. The Court in fact had given an opportunity to the petitioner to place on record the order of the liquidator which was mentioned in paragraph 16 of the writ application. Counsel for the petitioner however, says that though he had applied for certified copy of the order and petition of liquidation case but the same could not be made available to him from which he could demonstrate that his application filed before the liquidator is pending.

Counsel for the petitioner placed reliance on an order of the State Government in the Cooperative Department contained in Memo no. 4152 dated 07.05.2005, a copy whereof is also now being placed on record of this case, wherein the State Government had taken certain policy decision for payment of salary of the Paid Manager in exercise of its power U/s 66b of the Bihar Cooperative Societies Act 1925.

This court is not concerned with these decision-taken by the State Government as it is an internal arrangement of the state government with the bank. It however goes without saying that the petitioner will also get benefit of the scheme as contemplated in the Government order dated 07.05.2005 in the case the same is implemented in cases of other similarly situated Paid Managers of the bank in question. 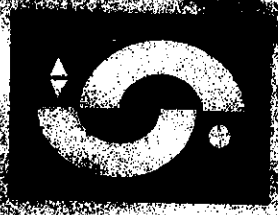
